HSB 119 - Representative Lundgren was recognized to take up HSB 119; A bill for an act concerning the office of the chief information officer relating to designation of certain information technology staff, background checks, and the technology advisory council. The subcommittee report of Reps. Lundgren, Fisher and Finkenauer was submitted and signed. Rep. Lundgren gave opening remarks, discussion followed and with closing remarks Rep. Lundgren moved the bill. Chair Cownie moved HSB 119, as a committee bill on a roll call vote. Motion carried with 23 ayes.

HSB 125 - Representative Landon was recognized to take up HSB 125; A bill for an act relating to licensed real estate professionals and real estate disclosure. The subcommittee report of Reps. Landon, Mohr and McConkey was submitted and signed. Rep. Landon gave opening remarks and asked permission to take up amendment 125.1000. Amendment 125.1000 passed on a voice vote. Discussion followed and with closing remarks Rep. Landon moved the bill. Chair Cownie moved HSB 125, as amended, as a committee bill on a roll call vote. Motion carried with 23 ayes.

HSB 126 - Representative Landon was recognized to take up HSB 126; A bill for an act relating to certain charges for consumer credit transactions. The subcommittee report of Reps. Landon, Holz and Kressig was submitted and signed. Rep. Landon gave opening remarks and asked permission to take up amendment 126.779. Amendment 126.779 passed on a voice vote. Discussion followed and with closing remarks Rep. Landon moved the bill. Chair Cownie moved HSB 126, as amended, as a committee bill on a roll call vote. Motion carried with 23 ayes.

With no further business to come before the Committee, Chairman Cownie gave closing remarks and moved to adjourn and Representative Best seconded the motion.
