The Agriculture Committee meeting was called to order on Thursday, March 2, 2017 at 10:33 by Senator Zumbach.

The secretary took roll silently and excused those not present until they arrived. All committee members were present.

Senator Zumbach asked to approve minutes from the 2/23/2017 meeting. No corrections or additions. Minutes were approved.

Senator Zumbach Recognized Senator Kinney for Democrat caucus announcement. Committee recessed for caucus at 10:34. Resumed committee meeting at 11:16

Upon reconvening the meeting, Senator Zumbach introduced Senator Kapucian for [SF 329](#).

Senator Kapucian gave opening remarks on [SF 329](#). There was no discussion of [SF 329](#).

Senator Kapucian gives final remarks and moved [SF 329](#) to be placed on the calendar as an individual bill.

Senator Zumbach asked Senator Kinney, how he wished to vote. Short form vote was requested with result of all members voting AYE and no members voting NAY.

The motion passed unanimously. [SF 329](#) moves to the calendar as an individual bill.

Senator Zumbach turned the chair responsibility to Senator Brown.

Senator Brown asked Senator Zumbach for the subcommittee report for [SSB 1144](#).

Senator Zumbach gave opening remarks.

Senator Kinney shared his remarks.

Senator Zumbach gave final remarks on the bill and asked to move [SSB 1144](#) to be placed on the calendar as a committee bill.

Senator Kinney requested a record roll call vote.

Those voting aye: Zumbach, Brown, Kinney, Bowman, Costello, Edler, Kapucian, Rosenboom, Segebart, Shipley. Those voting nay; Hart, Ragan, Taylor.

The motion passed 10-3. [SSB 1144](#) moves to the calendar as a committee bill.

Senator Brown asked for the subcommittee report for [SSB 1146](#)

Senator Zumbach gave his opening remarks and indicated there are amendments.

Senator Kinney gave opening remarks on amendment 1146.961

There was no discussion on the amendment.

Senator Kinney gave final remarks on the amendment and called for a short form vote on amendment 1146.961. Record roll call vote was requested.

Eight members voted nay, five members voted aye. Those voting Nay: Zumbach, Brown, Costello, Edler, Kapucian, Rosenboom, Segebart, Shipley. Those voting aye; Kinney, Bowman, Hart, Ragan, Taylor. Vote on amendment 1146.961 was defeated 8-5.

Senator Zumbach gave opening remarks on amendment 1146.992

Senator Kapucian had remarks on the amendment.

Senator Zumbach gave final remarks and asked to move amendment 1146.992 to [SSB 1146](#).

Senator Kinney, asked for a short form vote. Record vote was requested. All members voted aye. The motion passed unanimously.

Senator Brown stated Amendment [SSB 1146](#).992 has passed and asked if there is further discussion on [SSB 1146](#) as amended.

There was no discussion.

Senator Zumbach gave final remarks on [SSB 1146](#) as amended and asked the bill be placed on the calendar as a committee bill under Rule 40.

Senator Kinney requested a roll call vote.

Eight members voted aye, five members voted nay. Those voting aye: Zumbach, Brown, Costello, Edler, Kapucian, Rosenboom, Segebart, Shipley. Those voting nay; Kinney, Bowman, Hart, Ragan, Taylor.

Senator Brown stated the motion has passed 8-5. [SSB 1146](#), as amended, moves to the calendar as a committee bill under Rule 40.

Senator Brown turned meeting chair back to Senator Zumbach.

Senator Zumbach asked for any other business to come to the committee, seeing none Senator Shipley motioned for adjournment at 11:35.
