Sen. Garrett, chairman, called the meeting to order at 3:15 p.m. The secretary took roll silently.

All members were present. No objections to minutes from the March 1, 2017, meeting, and minutes were approved.

Sen. Garrett recognized Sen. Lofgren for [SSB 1063](#). Sen. Lofgren gave opening remarks. There were no additional comments, and Sen. Lofgren moved the bill. Sen. Allen asked for short form vote, and the bill passed Ayes: 11, Nays: 0.

At 3:20 p.m., both parties went to caucus. Meeting in recess. Meeting resumed at 3:43 p.m. All members were present.

Sen. Garrett turned the meeting over to Sen. Lofgren to chair.

Sen. Lofgren recognized Sen. Garrett for [SSB 1172](#). Sen. Garrett gave opening remarks. He recognized Sen. McCoy, who introduced amendment .1048. Sen. McCoy moved the amendment. Sen. Allen asked for short form vote, and .1048 passed Ayes: 11, Nays: 0.

Sen. McCoy introduced amendment .1045. Comments by Senators Garrett, Quirmbach, Chelgren, McCoy and Allen. Sen. McCoy moved the amendment. Sen. Allen asked for short form vote, and .1045 passed Ayes: 10, Nays: 1.

Sen. McCoy introduced amendment .1050. Comments by Senators Chelgren, Quirmbach, Garrett and McCoy. Sen. McCoy moved the amendment. Roll call vote was taken.

Amendment defeated Ayes: 5, Nays: 6.

Sen. McCoy introduced amendment .1049. Comments by Sen. Garrett. Sen. Quirmbach requested grammatical correction in bill. Sen. McCoy moved the bill. Sen. Allen asked for short form vote, and .1045 passed Ayes: 11, Nays: 0.

Sen. Garrett gave closing remarks on [SSB 1172](#) and moved the bill as amended. Roll call vote was taken, and the bill as amended was passed onto the floor under Rule 40, Ayes: 7, Nays: 4.

There was no other business. Sen. Allen moved to adjourn. No objections. The meeting adjourned at 4:30 p.m.
