Chair Vander Linden recognized Representative Rizer for opening comments on [HF 521](#), a bill for an act relating to alcoholic beverage control and matters under the purview of the alcoholic beverages division of the department of commerce. Representative Rizer introduced Amendment 1326 to [HF 521](#). After discussion, Representative Rizer moved Amendment 1326 and it passed by voice vote. Following discussion, Chair Vander Linden recognized Representative Rizer for closing comments on [HF 521](#), as amended. Representative Rizer moved [HF 521](#), as amended. A record roll call was taken and [HF 521](#), as amended, passed (22-0). [HF 521](#) moves to the house floor as a committee bill.

Chair Vander Linden recognized Representative Kaufmann for opening comments on [HSB 170](#), a bill for an act establishing a motor vehicle insurance verification program, establishing fees, and including penalty and effective date provisions. Representative Kaufmann introduced Amendment 1513 to [HSB 170](#). After discussion, Representative Kaufmann moved Amendment 1513 and it passed by voice vote. Following discussion, Chair Vander Linden recognized Representative Kaufmann for closing comments on [HSB 170](#), as amended. Representative Kaufmann moved [HSB 170](#), as amended. A record roll call was taken and [HSB 170](#), as amended, passed (18-4) (Nays: Isenhart, Kearns, Kurth, Wolfe). [HSB 170](#) moves to the house floor as a committee bill.
