The Ways and Means Committee was called to order by Chair Vander Linden at 2:00 pm.

Roll Call was taken with a quorum present.

As there were no corrections, amendments, and/or deletions to the March 15th meeting minutes, Chair Vander Linden moved to approve the minutes as distributed.

The following bills were assigned to Subcommittees: None.

Both parties went to caucus at 2:01 pm and reconvened at 2:37 pm.

Chair Vander Linden recognized Representative Pettengill for opening comments on [HSB 121](#), a bill for an act relating to the technical administration of the tax laws by the department of revenue, including administration of the research activities credit, income taxes, and the flood mitigation program, and including effective date and retroactive applicability provisions. Following discussion, Chair Vander Linden recognized Representative Pettengill for closing comments on [HSB 121](#). Representative Pettengill moved [HSB 121](#). A record roll call was taken and [HSB 121](#) passed (24-0) (Nays: None). [HSB 121](#) moves to the house floor as a committee bill.

Chair Vander Linden recognized Representative Pettengill for opening comments on [HF 186](#), a bill for an act providing for the imposition of the local hotel and motel tax by a land use district. Representative Pettengill introduced Amendment 714 to [HF 186](#). After discussion, Representative Pettengill moved Amendment 714 and it passed by voice vote. Following discussion, Chair Vander Linden recognized Representative Pettengill for closing comments on [HF 186](#), as amended. Representative Pettengill moved [HF 186](#), as amended. A record roll call was taken and [HF 186](#), as amended, passed (21-3) (Nays: Jacoby, Bennett, Kearns). [HF 186](#) moves to the house floor as a committee bill.

Chair Vander Linden recognized Representative Pettengill for opening comments on [HF 42](#), a bill for an act relating to the property tax exemption for the value added by certain geothermal heating or cooling systems and including applicability provisions. Representative Pettengill introduced Amendment 900 to [HF 42](#). After discussion, Representative Pettengill moved Amendment 900 and it passed by voice vote. Following discussion, Chair Vander Linden recognized Representative Pettengill for closing comments on [HF 42](#), as amended.

Representative Pettengill moved [HF 42](#), as amended. A record roll call was taken and [HF 42](#), as amended, passed (24-0) (Nays: None). [HF 42](#) moves to the house floor as a committee bill.
