The Ways and Means Committee was called to order by Chair Vander Linden at 2:30 pm. Roll Call was taken with a quorum present.

As there were no corrections, amendments, and/or deletions to the March 22nd meeting minutes, Chair Vander Linden moved to approve the minutes as distributed.

The following bills were assigned to Subcommittees: None.

Both parties went to caucus at 2:30 pm and reconvened at 3:20 pm.

Chair Vander Linden recognized Representative Mohr for opening comments on [HSB 190](#), a bill for an act providing for the establishment of first-time homebuyer savings accounts in Iowa, including related individual income tax exemptions, and including applicability provisions.

Representative Mohr introduced Amendment 1727 to [HSB 190](#). After discussion, Representative Mohr moved Amendment 1727 and it passed by voice vote. Following discussion, Chair Vander Linden recognized Representative Mohr for closing comments on [HSB 190](#), as amended. Representative Mohr moved [HSB 190](#), as amended. A record roll call was taken and [HSB 190](#), as amended, passed (22-0) (Nays: None). [HSB 190](#) moves to the house floor as a committee bill.

Chair Vander Linden recognized Representative Maxwell for opening comments on [HF 510](#), a bill for an act authorizing the department of natural resources to establish certain fees at state parks and recreation areas. Representative Maxwell introduced Amendment 1480 to [HF 510](#). After discussion, Representative Maxwell moved Amendment 1480 and it passed by voice vote. Following discussion, Chair Vander Linden recognized Representative Maxwell for closing comments on [HF 510](#), as amended. Representative Maxwell moved [HF 510](#), as amended. A record roll call was taken and [HF 510](#), as amended, passed (23-0) (Nays: None). [HF 510](#) moves to the house floor as a committee bill.

Chair Vander Linden recognized Representative Maxwell for opening comments on [HF 550](#), a bill for an act providing for the department of agriculture and land stewardship's administration of certain functions, relating to forest and fruit tree reservation requirements, the name of the state soil conservation committee, financing of soil conservation and water quality practices, the health of agricultural animals, issuance of two-year licenses and the collection of related fees imposed upon persons engaged in the marketing of agricultural animals and mining operations, license fees imposed upon pesticide dealers, tickets for delivering commodities in bulk, labeling of motor fuel pumps dispensing certain ethanol blended gasoline, the use of scales, providing for penalties, making penalties applicable, and including effective date provisions. Following discussion, Chair Vander Linden recognized Representative Maxwell for closing comments on

[HF 550](#). Representative Maxwell moved [HF 550](#). A record roll call was taken and [HF 550](#) passed (23-0) (Nays: None). [HF 550](#) moves to the house floor as a committee bill. With no other business to come before the Committee, Representative Carlin moved to arise at 3:30 pm.
