Chair management was turned over to Vice Chairman Behn. Chairman Behn recognized Senator Feenstra, Subcommittee Chair for [SSB 1187](#), for opening remarks on the bill and Amendment .2100. Floor was opened to discussion. A Short Form Vote on Amendment .2100 was taken, 15 AYES. Senator Feenstra presented closing remarks on [SSB 1187](#). A Short Form Vote on [SSB 1187](#), as amended, passed by a vote of, 15 AYES. The meeting was turned back over to Chairman Feenstra.

Chairman Feenstra recognized Senator Schultz, Subcommittee Chair, who delivered [SSB 1052](#) to committee for opening comments. Floor was opened to discussion. A Short Form Vote on [SSB 1052](#) was taken. [SSB 1052](#) passed by a vote of 15 AYES.

Chairman Feenstra recognized Senator Breitbach, Subcommittee Chair, who delivered [SF 418](#) and Amendment .2002 to committee for opening comments. Floor was opened to discussion. A Short Form Vote on Amendment .2002 was taken, 15 AYES. A Short Form Vote on [SF 418](#), as amended, was taken, 15 AYES.

Chairman Feenstra recognized Senator Anderson, Subcommittee Chair, who delivered [SF 177](#) and Amendment .1957 to committee and gave opening comments. Floor was opened to discussion. A Short Form Vote on Amendment .1957 was taken, 15 AYES. A Short Form Vote on [SF 177](#), as amended, was taken, 15 AYES.

Chairman Feenstra recognized Senator Smith, Subcommittee Chair, who delivered [HF 607](#) to committee and gave opening comments. Floor was opened to discussion. A Short Form Vote on [HF 607](#) was taken, 15 AYES.

Chairman Feenstra recognized Senator Smith who delivered [SF 425](#) and Amendment .1662 to the committee and made opening remarks. Floor was opened to discussion. A Short Form Vote on Amendment .1662 was taken, 15 AYE. A Short Form Vote on [SF 425](#), as amended, was taken, 14 AYES, 1 NAY (Senator Bolkcom).
