Chair Vander Linden recognized Representative Baltimore for opening comments on [HF 252](#), a bill for an act relating to the calculation of certain court costs in probate matters, and including applicability provisions. Representative Baltimore introduced Amendment 2182 to [HF 252](#).

After discussion, Representative Baltimore moved Amendment 2182 and it passed by voice vote. Following discussion, Chair Vander Linden recognized Representative Baltimore for closing comments on [HF 252](#), as amended. Representative Baltimore moved [HF 252](#), as amended. A record roll call was taken and [HF 252](#), as amended, passed (22-0) (Nays: None). [HF 252](#) moves to the house floor as a committee bill.

Chair Vander Linden recognized Representative Nunn for opening comments on [HSB 180](#), a bill for an act relating to the powers and duties of the secretary of state, including requirements for persons filing certain documents or records with the office of secretary of state, the use of certain fees associated with business filings, and the unauthorized filing of commercial records, and providing penalties. Representative Nunn introduced Amendment 2187 to [HSB 180](#). After discussion, Representative Nunn moved Amendment 2187 and it passed by voice vote. Following discussion, Chair Vander Linden recognized Representative Nunn for closing comments on [HSB 180](#), as amended. Representative Nunn moved [HSB 180](#), as amended. A record roll call was taken and [HSB 180](#), as amended, passed (14-8) (Nays: Jacoby, Gaskill, Isenhart, Kearns, Kurth, McConkey, Prichard, Wolfe). [HSB 180](#) moves to the house floor as a committee bill.
