Chair Vander Linden recognized Representative Cownie for opening comments on [HSB 43](#), a bill for an act relating to the approval and imposition of local option sales and services taxes.

Following discussion, Chair Vander Linden recognized Representative Cownie for closing comments on [HSB 43](#). Representative Cownie moved [HSB 43](#). A record roll call was taken and [HSB 43](#) passed (24-1) (Nays: Baltimore). [HSB 43](#) moves to the house floor as a committee bill.

Chair Vander Linden recognized Representative Cownie for opening comments on [HSB 195](#), a bill for an act relating to Iowa's urban renewal law by excluding the school foundation property tax from certain divisions of tax revenue and including effective date and applicability provisions.

Following discussion, Chair Vander Linden recognized Representative Cownie for closing comments on [HSB 195](#). Representative Cownie moved [HSB 195](#).
