Presentation: Legislative Update on Iowa Nutrient Research Center, An Overview

- 1. Iowa Nutrient Reduction Strategy (NRS) concentrated on Management Practices, Land Use Practices, Edge-of-Field Practices, and Non-Categorial Research. The goal of the NRS is to look at scientific facts and consists of an advisory council and researchers from the three universities in the state of Iowa. An overview of Research Dollars and Resources was presented.
- 2. Dr. Matthew Helmers presented on drainage water quality, impacts of cover crops, differences in till vs. no-till, functional benefits of prairie vs row crop fields, and potential applicability across Iowa.

III. Dr. Thomas Isenhart presented on saturated buffers for removing nitrate from subsurface drainage. Alternatives for tile-drained landscapes. USDA Conservation Fact Sheet (December 2016). Research done here in Iowa is having national impact.
