[HSB 512](#) passed with a vote of 11-10 (Aye-Highfill, Hager, Bloomingdale, Deyoe, Gassman, Heartsill, Jones, Kaufmann, Landon, McKean, Sheets, Nay-Staed, Carlson, Gaskill, Kressig, Kurth, Lensing, Meyer, Nielsen, Thede, Wolfe) moving to the house as a committee bill for consideration.

Chairman Highfill recognized Representative Jones for opening comments on [HF 2013](#)—A bill for an act relating to the assessment of fees when a public defender or designee requests copies of certain documents.

There was discussion.
