Representative Carlson (CH) called the committee to order at 3:05 pm.

The committee stood at ease at 3:06 pm for both parties to caucus.  
The committee reconvened at 3:38 pm.

The minutes from the previous meeting were approved.

Representative Carlson (CH) recognized Representative Hinson for opening remarks on [HF 2248](#) (A bill for an act relating to special certificates issued to aircraft manufacturers, transporters, and dealers, providing fees, making penalties applicable, and including effective date and applicability provisions.) After discussion, the Chair recognized Representative Hinson for closing remarks on [HF 2248](#). Representative Hinson moved [HF 2248](#). The bill passed with a roll call vote of 20 ayes to 0 nays with 1 absent or not voting (Jacoby) Having received a constitutional majority, the bill will move to the floor as a committee bill.

Representative Carlson (CH) recognized Representative Hinson for opening remarks on [HJR 2006](#) (A joint resolution opposing a law of this state relating to the revocation, suspension, issuance, or reinstatement of driver's licenses to convicted drug offenders, and including effective date provisions.) After discussion, the Chair recognized Representative Hinson for closing remarks on [HJR 2006](#). Representative Hinson moved [HJR 2006](#). The bill passed with a roll call vote of 20 ayes to 0 nays with 1 absent or not voting (Jacoby). Having received a constitutional majority, the bill will move to the floor as a committee bill.

Representative Carlson (CH) recognized Representative Wills for opening remarks on [HF 513](#) (A bill for an act relating to the safe operation of bicycles, and making penalties applicable.) Representative Wills noted there is an amendment.

The Chair recognized Representative Worthan for opening remarks on amendment [HF 513.3157](#). After discussion, the Chair recognized Representative Worthan for closing remarks on amendment [HF 513.3157](#). Representative Worthan moved the amendment. The amendment was adopted by a voice vote.

After discussion, the Chair recognized Representative Wills for closing remarks on [HF 513](#) as

amended. Representative Wills moved [HF 513](#) as amended. The bill passed with a roll call vote of 13 ayes to 7 nays (Forbes, Cohoon, Heddens, Miller, P., Olson, Ourth, Smith, R.) with 1 absent or not voting (Jacoby). Having received a constitutional majority, the bill will move to the floor as a committee bill.

As there was no other business to come before the committee, Representative Sieck moved to arise.

The committee adjourned at 3:50 pm.
