Subcommittee assignments were passed out to the committee members.

Minutes from 2/13/2018 were unanimously approved.

Senator Smith recognized Senator Dawson for opening remarks on [SSB 3023](#) and amendment 3356. A voice vote was requested on the amendment. 3356 passed unanimously. A voice vote was requested and held on [SSB 3023](#). [SSB 3023](#) passed unanimously and will be passed to the calendar as a committee bill under Rule 40.

Senator Smith recognized Senator Schneider for [SSB 3019](#), amendment 3277 and amendment 2741. A voice vote was held on amendment 3277. Amendment 3277 passed unanimously. Amendment 2741 passed unanimously with a voice vote. A voice vote was requested and held on [SSB 3019](#), as amended, and was approved unanimously as a committee bill to be passed to the calendar under Rule 40.

Senator Brown was recognized for remarks on [SSB 3174](#). A voice vote was requested. [SSB 3174](#) passed unanimously. [SSB 3174](#) passes to the calendar as a committee bill.

Senator Schultz was recognized for [SSB 3146](#). A voice vote was held. [SSB 3146](#) passes unanimously to the calendar as a committee bill.

Senator Smith turned the chair over to Senator Chapman.

Senator Smith reported on [SSB 3084](#), amendment 2876 and amendment 3258. A voice vote was requested on the amendment. Amendment 2876 passed unanimously. A voice vote was held for amendment 3258. 3258 passed unanimously. [SSB 3084](#), as amended, passes unanimously to the calendar as a committee bill under Rule 40.

Senator Smith reported on [SSB 3128](#) and amendment 3321. A voice vote was requested on the amendment. Amendment 3321 passed unanimously. A voice vote was requested and held for [SSB 3128](#). [SSB 3128](#), as amended, passes unanimously to the calendar as a committee bill under Rule 40.

Senator Smith reported on [SSB 3116](#). A record roll call was held. [SSB 3116](#) passed, 9 AYES, 5 NAYS (Senators Bisignano, Danielson, Dvorsky, Horn and Jochum) with 1 Excused (Schneider). [SSB 3116](#) is adopted and moves to the calendar as a Senate Joint Resolution.
