The meeting came to order at 1:03 pm

The previous minutes were approved.

Subcommittee assignments were distributed.

Democrats and Republicans went to caucus.

Chairwoman Senator Sinclair recognized Senator Chelgren for [HF 2235](#).

Senator Chelgren introduced [HF 2235](#), delivered the subcommittee report, and gave opening comments on the bill.

Senator Chelgren addressed the intention of running an amendment on the bill once it reached the floor regarding clarification and parameters in the bill.

Chairwoman Senator Sinclair recognized Ranking Member Senator Quirmbach.

Ranking Member Senator Quirmbach spoke against the bill and discussed the ARFP process, statewide assessments, and shared a letter from the federal Department of Education regarding Iowa Education standards. Ranking Member Senator Quirmbach shared his opinion on the assessment process and alignment of the assessment with teaching.

Chairwoman Senator Sinclair recognized Senator Hart.

Senator Hart spoke against the bill and mirrored many of Ranking Member Senator Quirmbach's comments. Senator Hart appreciated the efforts of the committee to create an aligned test for the classrooms.

Chairwoman Senator Sinclair spoke to the committee regarding the bill. Chairwoman Senator Sinclair expressed her agreement with many of Senator Hart and Ranking Member Senator Quirmbach's comments and gave some further background on how this bill came before the committee.

Chairwoman Senator Sinclair asked Senator Chelgren to yield, Senator Chelgren complied.

Chairwoman Senator Sinclair asked Senator Chelgren to share more specific details about the amendment that will be filed on the floor in a response to some of the concerns from Ranking Member Senator Quirmbach and Senator Hart.

Chairwoman Senator Sinclair recognized Senator Hart.

Senator Hart expressed another disappointment in the subcommittee process in which the meeting felt rushed. Chairwoman Senator Sinclair responded to Senator Hart expressing the majority's attempts to make the meeting as open as possible and the time frame for the subcommittee was extended.

Chairwoman Senator Sinclair recognized Ranking Member Senator Quirmbach.

Ranking Member Senator Quirmbach spoke on the subcommittee and hoped in the future that if similar situations occur, the subcommittee would adjourn and meet again at a more opportune

time for the public. He once again urged the committee to vote against the bill.  
 Chairwoman Senator Sinclair recognized Senator Chelgren.  
 Senator Chelgren gave closing comments on the bill and moved its passage.  
[HF 2235](#) passed 12-3 with Senators Quirmbach, Danielson, and Hart voting no and was moved to the calendar.  
 Senator C. Johnson moved to adjourn.
