Representative Wills for closing remarks on [SF 2231](#). Representative Wills moved [SF 2231](#).

The bill passed with a roll call vote of 17 ayes to 2 nays (Heddens, Smith, R.) with 2 absent or not voting (Jacoby, Taylor, R.). Having received a constitutional majority, the bill will move to the floor as a committee bill.

Representative Carlson (CH) recognized Representative Hinson for opening remarks on [SF](#)

[2293](#) (A bill for an act relating to motor vehicles, including provisions concerning record retention at established places of business of motor vehicle dealers, electronic titling and registration of motor vehicles, and warranties and recalls of motor vehicle franchises.) After discussion, the Chair recognized Representative Hinson for closing remarks on [SF 2293](#).

Representative Hinson moved [SF 2293](#). The bill passed with a roll call vote of 19 ayes to 0 nays with 2 absent or not voting (Jacoby, Taylor, R.). Having received a constitutional majority, the bill will move to the floor as a committee bill.

Representative Carlson (CH) recognized Representative Maxwell for opening remarks on [SF](#)

[2324](#) (A bill for an act allowing certain vans and pickups to be used as school buses.) After discussion, the Chair recognized Representative Maxwell for closing remarks on [SF 2324](#).

Representative Maxwell moved [SF 2324](#). The bill passed with a roll call vote of 19 ayes to 0 nays with 2 absent or not voting (Jacoby, Taylor, R.). Having received a constitutional majority, the bill will move to the floor as a committee bill.
