Chair Vander Linden recognized Representative Kaufmann for opening comments on [HSB 683](#), a bill for an act excluding entities under the control of an institution of higher learning governed by the state board of regents from the sales tax exemption for sales where the profits are used by or donated to certain nonprofit entities for educational, religious, or charitable purposes. Representative Kaufmann introduced Amendment 5172 to [HSB 683](#). After discussion, Representative Kaufmann moved Amendment 5172 and it passed by voice vote. Following discussion, Chair Vander Linden recognized Representative Kaufmann for closing comments on [HSB 683](#), as amended. Representative Kaufmann moved [HSB 683](#), as amended. A record roll call was taken and [HSB 683](#), as amended, passed (23-0-2) (Nays: None). [HSB 683](#) moves to the house floor as a committee bill.

Chair Vander Linden recognized Representative Baltimore for opening comments on [SF 2388](#), a bill for an act relating to the assessment and taxation of telephone and telegraph company property for certain assessment years and including effective date and applicability provisions. Representative Baltimore introduced Amendment 5206 to [SF 2388](#). After discussion, Representative Baltimore moved Amendment 5206 and it passed by voice vote. Following discussion, Chair Vander Linden recognized Representative Baltimore for closing comments on [SF 2388](#), as amended. Representative Baltimore moved [SF 2388](#), as amended. A record roll call was taken and [SF 2388](#), as amended, passed (14-9-2) (Nays: Bennett, Forbes, Gaskill, Isenhart, Kearns, Kurth, McConkey, Prichard, Wolfe). [SF 2388](#) moves to the house floor as a committee bill.
