The Ways and Means Committee was called to order by Chair Vander Linden at 10:00 am. Both parties went to caucus at 10:00 am and reconvened at 1:53 pm. Roll Call was taken with a quorum present.

As there were no corrections, amendments, and/or deletions to the April 11th meeting minutes, Chair Vander Linden moved to approve the minutes as distributed.

Chair Vander Linden recognized Representative Cownie for opening comments on [HSB 671](#), a bill for an act relating to state and local revenue and finance by modifying the income taxes, the sales and use taxes and local option sales tax, the hotel and motel excise tax, the automobile rental excise tax, the Iowa educational savings plan trust, and the disabilities expenses savings plan trust, making penalties applicable, and including immediate effective date and retroactive and other applicability provisions. Representative Cownie introduced Amendment 5235 to [HSB 671](#). Representative Prichard then introduced Amendment 5239 to Amendment 5235. After discussion, Representative Prichard moved Amendment 5239 and failed by record roll call vote (10-13-2). Representative Isenhart then introduced Amendment 5247 to Amendment 5235. Following discussion, Representative Isenhart moved Amendment 5247 and it failed by record roll call vote (10-13-2). That dispensed of all Amendments to Amendment 5235. Following discussion, Representative Cownie moved Amendment 5235 and it passed by voice vote. Chair Vander Linden recognized Representative Cownie for closing comments on [HSB 671](#), as amended. Representative Cownie moved [HSB 671](#), as amended. A record roll call was taken and [HSB 671](#), as amended, passed (13-10-2) (Nays: Jacoby, Bennett, Forbes, Gaskill, Isenhart, Kearns, Kurth, McConkey, Prichard, Wolfe). [HSB 671](#) moves to the floor as a committee bill. With no other business to come before the Committee, Representative Nunn moved to arise at 3:13 pm.
