Meeting was called to order at 2:18 p.m.

Attendance was taken silently by secretary.

Minutes from March 29th meeting were distributed. Minutes were unanimously approved.

Both parties went to caucus.

Meeting reconvened at 2:49 p.m.

Following caucus Chairman Feenstra called the meeting back to order and chair management was turned over to Vice Chairman Behn who recognized Sen. Feenstra for opening remarks on [SF 2074](#).

- Sen. Feenstra wanted to make a clarification regard tax rebate fund.

Floor was open for discussion

Chairman Behn recognized Sen. Quirmbach. Sen. Quirmbach asked Sen. Feenstra to yield.

Question asked whether this was retro to 1/20/15. Yes.

A short form vote was taken. Two Senators wanted to be recorded as a no vote: Sen. Behn and Sen. Quirmbach. [SF 2074](#) passed.

Chairman Behn recognized Sen. Feenstra for [SF 2152](#). Subcommittee report turned in without signature by Sen. Bolkcom.

Floor open for discussion on [SF 2152](#).

Motion to move bill. Short form vote taken. Bill passed unanimously.

Chair management was returned to Chairman Feenstra who asked that a subcommittee of the whole would meet on [SF 2372](#).

Chair recognized Sen. Edler as Chairman of Subcommittee of the Whole on [SF 2372](#).

Floor was open for discussion.

Sen. Edler asked if anyone from the lobby wished to discuss position on [SF 2372](#).

- Dave Shumer [Med Pharm Iowa] addressed the subcommittee re THC cap.
- Bruce Basten spoke in favor of including Veterans suffering with PTSD being included
- Peter Komindowski spoke in opposition of bill.

Subcommittee chairman Edler recognized Sen. Bolkcom for comments.

Subcommittee chairman Edler recognized Sen. Feenstra for comment regarding reason bill in

Ways/Means because it deals with tax money.

Subcommittee chair Edler made motion to rise from subcommittee.

Chairman Feenstra moved [SF 2372](#). Roll call vote was taken with 11 Ayes, 3 Nays [Sen. Breitbach, Sen. Carlin and Sen. Dawson]

Bill passed, moved to Ways/Means Calendar as approved Committee Bill.

Seeing no additional business Senator Smith moved to adjourn at 3:17 p.m.
