Republicans and Democrats briefly caucused.

Chairman Senator Rozenboom turned the Chair over to Vice Chair Senator Shipley.

Vice Chair Senator Shipley recognized Senator Rozenboom for [SF 46](#).

Chairman Senator Rozenboom introduced [SF 46](#), provided the subcommittee report, and gave opening comments on the bill.

Chairman Senator Rozenboom introduced Senate Amendment 46.88.

Vice Chair Senator Shipley opened the floor to discussion. Discussion ensued. Seeing no further discussion, Chairman Senator Rozenboom moved the amendment.

Senate Amendment 46.88 passed through a short form voice vote.

Vice Chair Senator Shipley asked if there was any further discussion on [SF 46](#). Discussion ensued. Seeing no further discussion, Senator Rozenboom gave closing comments and moved [SF 46](#).

[SF 46](#), as amended, passed on a roll call vote 8-4 as a committee bill with Senators Rozenboom, Shipley, Behn, Cournoyer, Kapucian, Segebart, Sweeney, and Zumbach voting yes and Senators Boulton, Celsi, Lykam, and J. Smith voting no.

Vice Chair Senator Shipley turned the Chair over to Chairman Senator Rozenboom.

Chairman Rozenboom recognized Senator Cournoyer for [SF 47](#). Senator Cournoyer introduced [SF 47](#), provided the subcommittee report, and gave opening comments on the bill.

Senator Cournoyer introduced Senate Amendment 47.83.

Chairman Senator Rozenboom opened the floor to discussion. Discussion ensued. Seeing no further discussion, Senator Cournoyer gave closing comments and moved the amendment.

Senate Amendment 47.83 passed unanimously on a short form voice vote.

Chairman Senator Rozenboom asked if there was any further discussion on [SF 47](#). Discussion ensued. Seeing no further discussion, Senator Cournoyer gave closing comments and moved [SF 47](#).

[SF 47](#), as amended, passed unanimously on a short form voice vote as a committee bill.

Chairman Senator Rozenboom recognized Senator Cournoyer for [SF 50](#).

Senator Cournoyer introduced [SF 50](#), provided the subcommittee report, and gave opening comments on the bill.

Chairman Senator Rozenboom opened the floor to discussion. Discussion ensued. Seeing no further discussion, Senator Cournoyer gave closing comments and moved [SF 50](#). [SF 50](#) passed unanimously through a roll call voice vote as a committee bill. Senator Boulton moved to adjourn. The committee adjourned at 3:50 pm.
