The bill as amended passed as a committee bill with 20 ayes and 3 nays (Mascher, Bacon and Lensing).

The amendment failed on a voice vote. The bill passed committee with 13 ayes and 10 nays.(Mascher, Anderson, Cohoon, Derry, Donahue, Hunter, Konfrst, Lensing, Nielson and Steckman.)

Representative Sexton was recognized to take up [HSB 59](#). Representative Sexton was recognized for amendment 59.47. Amendment 59.47 passed on a voice vote. Representative Sexton was recognized for closing comments on amendment 59.47 and moved [HSB 59](#) as amended. The bill was amended passed as a committee bill with 23 ayes and 0 nays.
