[HBS 110](#)- Chairperson Hite recognized Representative Holt for opening comments. Discussion was now open. Representative Holt motioned for adoption of Amendment 110.293. The Amendment passed with 11 ayes and 10 nays. With no further discussion, Chairperson Hite recognized Representative Holt for closing comments. The clerk called the vote 11 (aye)-10 (nay) 0 (absent) with the nay votes being Representatives Wolfe, Bennett, Derry, Konfrst, McKean, Meyer, Oldson, Olson, Sunde, Wessel-Kroeschell. [HSB 110](#) passed as a committee bill.
