Discussion was now open. With no further discussion, Chairperson Holt recognized Representative Mitchell for closing comments. The clerk called the vote 19 (aye)-0 (nay) 2 (absent) with the absent votes being Representatives Bergan and Olson. [HSB 136](#) passed as a committee bill.

[HSB 112](#)- Chairperson Holt recognized Representative Lohse for opening comments.

Discussion was now open. Representative Lohse motioned for adoption of Amendment 154. The Amendment passed with 19 ayes and 2 absent. With no further discussion, Chairperson Holt recognized Representative Lohse for closing comments. The clerk called the vote 19 (aye)-0 (nay) 2 (absent) with the absent votes being Representatives Bergan and Olson. [HSB 112](#) passed, as amended, as a committee bill.

[HSB 118](#)- Chairperson Holt recognized Representative Hinson for opening comments.

Discussion was now open. With no further discussion, Chairperson Holt recognized Representative Hinson for closing comments. The clerk called the vote 19(aye)- 0 (nay)-2 (absent) with the absent votes being Representatives Bergan and Olson. [HSB 118](#) passed as a committee bill.
