Chairwoman Lundgren called the meeting to order at 10:00 am.

Roll Call was read and a quorum was present.

As there were no corrections, amendments and/or deletions to the previous meeting minutes, they were unanimously approved.

The meeting stood at ease for both parties to caucus at 10:02 am.

The meeting reconvened at 11:28 am.

Chairwoman Lundgren recognized Representative Fry for opening remarks on [HF 212](#): A bill for an act relating to the operation of the board of medicine, the board of nursing, the board of pharmacy, and the dental board.

Chairwoman Lundgren recognized Representative Fry for opening remarks on amendment 212.497. The amendment passed on short form. The bill as amended was moved and passed with a vote of 13 Aye, 8 Nay, and 0 Absent (those voting nay were: Representatives Anderson, Brown-Powers, Derry, Forbes, Heddens, James, Konfrst, and Sunde). The bill will move to the House Floor as a Human Resources Committee bill.

Chairwoman Lundgren turned the chair over to Representative Meyer, A.

Chairwoman Meyer recognized Representative Lundgren for opening remarks on [HSB 214](#): A bill for an act relating to the prescribing and dispensing of self-administered hormonal contraceptives.

Chairwoman Meyer recognized Representative Lundgren for opening remarks on amendment 214.569. The amendment passed on short form. The bill as amended was moved and passed with a vote of 19 Aye, 2 Nay, and 0 Absent (those voting no were: Representatives Osmundson and Salmon). The bill will move to the House Floor as a Human Resources Committee bill.

Chairwoman Meyer, A. turned the chair over to Representative Lundgren.

Chairwoman Lundgren recognized Representative Bergan for opening remarks on [HF 538](#): A bill for an act relating to mandatory child abuse and dependent adult abuse reporter training requirements.

Chairwoman Lundgren recognized Representative Bergan for opening remarks on amendment 538.555. The amendment passed on short form. The bill as amended was moved and passed with a vote of 21 Aye, 0 Nay, and 0 Absent. The bill will move to the House Floor as a Human Resources Committee bill.

Chairwoman Lundgren recognized Representative Brink for opening remarks on [HF 447](#): A bill for an act relating to the dispensing of insulin in emergency situations, and providing for insurance coverage.

Chairwoman Lundgren recognized Representative Brink for opening remarks on amendment 447.704. The amendment passed by a vote of 11 Aye, 10 Nay, and 0 Absent. Those voting Nay were Representatives Wessel-Kroeschell, Anderson, Brown-Powers, Derry, Forbes, Heddens, James, Konfrst, Matson, and Sunde. The bill as amended was moved and passed with a vote of 21 Aye, 0 Nay, and 0 Absent. The bill will move to the House Floor as a Human Resources Committee bill.

Chairwoman Lundgren recognized Representative Fry for opening remarks on [HSB 206](#): A bill for an act relating to mental health and disability services, including the establishment of a children's behavioral health system and a children's behavioral health system state board, and requiring certain children's behavioral health core services.

Chairwoman Lundgren recognized Representative Fry for opening remarks on amendment 206.686. The amendment passed on short form. The bill as amended was moved and passed with a vote of 21 Aye, 0 Nay, and 0 Absent. The bill will move to the House Floor as a Human Resources Committee bill.

Chairwoman Lundgren recognized Representative Fry for opening remarks on [HF 548](#): A bill for an act relating to funding of county mental health and disability services by modifying provisions relating to the use of specified excess cash flow funds, and including effective date and retroactive applicability provisions.

Chairwoman Lundgren recognized Representative Fry for opening remarks on amendment 548.640. The amendment passed on short form. The bill as amended was moved and passed with a vote of 21 Aye, 0 Nay, and 0 Absent. The bill will move to the House Floor as a Human Resources Committee bill.

Chairwoman Lundgren recognized Representative Fry for opening remarks on [HF 549](#): A bill for an act relating to certain health-related entities including membership, reimbursement, and the elimination or combining of such entities.

Chairwoman Lundgren recognized Representative Fry for opening remarks on amendment 549.675. The amendment passed on short form. The bill as amended was moved and passed with a vote of 17 Aye, 4 Nay, and 0 Absent. Those voting no were Representatives Wessel-Kroeschell, Brown-Powers, Heddens, and James. The bill will move to the House Floor as a Human Resources Committee bill.

As there was no additional business to come before the committee, Representative Bergan moved to adjourn at 12:30 pm.
