Senator Chapman listed the bills, amendments, and Governor appointments that were to be considered.

Democrats and Republicans caucused at 4:51p.m. and reassembled at 5:25p.m.

Senator Chapman yielded the chair to Senator Koelker.

Senator Chapman was recognized to introduce [SSB 1035](#). Amendment 1035.246 was introduced by Senator Chapman and passed via voice vote. Amendment 1035.30 was introduced by Senator Sinclair and commented on by Senator Dawson then passed via voice vote. [SSB 1035](#) as amended was discussed and comments were made by Senator Mathis, Senator Quirnbach, and Senator Bolkcom and following closing comments was passed with a record roll call.

Senator Chapman was recognized to introduce [SSB 1202](#). Senator Bolkcom and Senator Mathis shared comments and [SSB 1202](#) passed with a record roll call.

Senator Koelker yielded the chair back to Senator Chapman.

Senator Breitbach was recognized to introduce [SSB 1205](#). Amendment 1205.516 by Senator Breitbach was passed via voice vote. [SSB 1205](#) as amended was commented on by Senator Peterson and passed via record roll call.

Senator Koelker was recognized to introduce [SSB 1173](#). [SSB 1173](#) passed via voice vote.

Senator Nunn was recognized to introduce [SSB 1174](#). [SSB 1174](#) passed via voice vote.

Senator Nunn was recognized to introduce [SSB 1177](#). [SSB 1177](#) passed via voice vote.

Senator Smith was recognized to report on Governor Appointment Debi Durham for Finance Authority Executive Director of Iowa. She passed via voice vote to be placed on the individual calendar.

Senator Johnson was recognized to report on Governor Appointment Philip Groner for Telecommunications and Technology Commission Executive Director. He passed via voice vote to be placed on the en bloc calendar.
