Senator Breitbach recognized Senator Kraayenbrink for opening remarks on [SF 488](#). After opening comments, Senator Kraayenbrink noted that there is an amendment ([SF 488.1068](#)). He then offered remarks on the amendment. The Chair asked for discussion and comments on amendment [SF 488.1068](#). There being none, the Chair asked for a short form vote and amendment [SF 488.1068](#) was unanimously approved. Back on [SF 488](#), as amended, Senator Kraayenbrink offered opening remarks and the amended bill. The Chair asked for discussion and comments. There being none, closing remarks on [SF 488](#), as amended, were made by Senator Kraayenbrink. Senator Breitbach recognized Senator Johnson for [SSB 1243](#). Senator Johnson moved to dissolve into subcommittee of the whole for consideration of Senate study bill 1243. There were no objections. Senator Johnson gave opening remarks on [SSB 1243](#). The Chair asked for discussion and comments. Seeing none, closing remarks on [SSB 1243](#) were made by Senator Johnson. A short form vote was requested by the Chair and [SSB 1243](#) passed out of subcommittee.
