Senator Breitbach called the meeting to order at 1:25 p.m.

Attendance was taken silently by the committee secretary.

Minutes of the previous meeting were unanimously approved.

Both parties caucused at p.m. 1:26 p.m., returning at 1:43 p.m.

The Chair turned the meeting over to Vice Chair, Senator Kraayenbrink, who recognized Senator Breitbach for opening remarks on [SSB 1257](#). Following Senator Breitbach's opening remarks, the Chair asked for discussion on [SSB 1257](#). Senator Bolkcom offered comment and his support of the bill. Senator Breitbach gave closing remarks on [SSB 1257](#) and a short form vote was requested. [SSB 1257](#) was unanimously approved and will move to the calendar.

Senator Kraayenbrink turned the meeting back to the Chair, Senator Breitbach, and he recognized Senator Kraayenbrink for opening remarks on [HF 758](#). Senator Kraayenbrink noted the strikeafter amendment, 1805, that replaces the House bill with the Senate bill and he was recognized for opening remarks on amendment 1805. Senator Breitbach asked for discussion on the amendment. Seeing none, Senator Kraayenbrink was recognized for closing remarks on amendment 1805. Amendment 1805 passed on a vote of 13 Yea, 6 Nay, 2 Absent. Senator Kraayenbrink was recognized for opening remarks on [HF 758](#), as amended. Senator Breitbach asked for discussion and comments. Senator Wahls offered commentary after which Senator Kraayenbrink was recognized for closing remarks on [HF 758](#), as amended. A roll call vote was requested and [HF 758](#), as amended, passed on a 13 Yea, 6 Nay, 2 Absent vote and will move to the calendar for consideration.

The Chair announced that Budget Subs will meet today and tomorrow to finalize numbers. The HHS Budget Sub will meet at 10:00 a.m. on Monday, April 22. The full Appropriations Committee will meet upon adjournment on Monday, April 22.

There being no further business, Senator T. Taylor moved to adjourn at 2:00 p.m.
