The Chair recognized Senator Lofgren for opening remarks on HF 756. Following opening remarks, Senator Breitbach asked for discussion and comments. There being none, Senator Lofgren was recognized for closing remarks on HF 756 and the Chair requested a short form vote. HF 756 was unanimously approved and will move to the calendar for consideration. The Chair recognized Senator Johnson for opening remarks on HF 765. Senator Johnson noted a strikeafter amendment, 1759, that replaces the House bill with the Senate bill. Following opening remarks on the amendment Senator Breitbach asked for discussion and comments. Senators Mathis and Bolkcom offered commentary. Senator Johnson was recognized for closing remarks on the amendment and 1759 passed on a vote of 12 Yea, 8 Nay. The Chair then recognized Senator Johnson for closing comments on HF 765, as amended. A roll call vote was requested and HF 765, passed on a 13 Yea, 7 Nay vote and will move to the calendar for

The Chair recognized Senator Guth for opening remarks on HF 759. Senator Guth noted a strikeafter amendment, 1761, that replaces the House bill with the Senate bill. Following opening remarks on the amendment, Senator Breitbach asked for discussion and comments. Senator Celi offered commentary after which amendment 1761 passed on a 12 Yea, 8 Nay vote. Senator Guth was recognized for closing remarks on HF 759, as amended, and the Chair asked for discussion or commentary on the amended bill. Senators Mathis and Bolkcom offered remarks. A roll call vote was requested on HF 759, as amended and the bill passed on a 12 Yea, 8 Nav vote and will move to the calendar for consideration.
