[HSB 258](#): Fry (Chair), Sorensen, & Heddens

The chair recognized Representative Best for opening comments on [SF 608](#). *(A bill for an act making appropriations to the department of cultural affairs, the economic development authority, the Iowa finance authority, the public employment relations board, the department of workforce development, the college student aid commission, and the state board of regents and certain regents institutions, and properly related matters. (Formerly [SSB 1250](#).)*

The chair recognized Representative Best for opening comments on Amendment 1991. After discussion and closing comments, Representative Best moved the amendment and passed on the vote 16 Yea, 7 Nay, and 2 Absent. The nay votes were Representatives Hall, Bennett, Breckenridge, Heddens, Mascher, Oldson, and Winckler. The absent members were Representatives Bearinger and Thede.

After discussion, the chair recognized Representative Best for closing comments on the bill as amended. Representative Best moved the bill as amended and passed on the vote 16 Yea, 7 Nay, and 2 Absent. The nay votes were Representatives Hall, Bennett, Breckenridge, Heddens, Mascher, Oldson, and Winckler. The absent members were Representatives Bearinger and Thede. The bill as amended will move to the House Floor as a Senate File.

After discussion and closing comments, Representative Sexton moved the amendment to the amendment and passed on the vote 23 Yea, 0 Nay, and 2 Absent. After discussion, the chair recognized Representative Worthan for closing comments on the amendment as amended. Representative Worthan moved the amendment as amended and it passed on short form.

After discussion, the chair recognized Representative Worthan for closing comments on the bill as amended. Representative Worthan moved the bill as amended and passed on the vote 14 Yea, 9 Nay, and 2 Absent. The nay votes were Representatives Hall, Bennett, Breckenridge, Heddens, Mascher, Oldson, Running-Marquardt, Williams, and Winckler. The absent members were Representatives Bearinger and Thede. The bill as amended will move to the House Floor as a Senate File.

The chair recognized Representative Mommsen for opening comments on [HF 754](#).

***(A bill for an act relating to hemp, including the regulation of hemp, providing for enforcement and the confiscation and destruction or disposal of certain property, providing for fees, making appropriations, including penalties, and providing implementation and effective date provisions. (Formerly [HF 733](#) and [HSB 241](#).)***

The chair recognized Representative Mommsen for opening comments on Amendment 1603.

After discussion and closing comments, Representative Mommsen moved the amendment and it passed on short form.

After discussion, the chair recognized Representative Mommsen for closing comments on the bill as amended. Representative Mommsen moved the bill as amended and passed on the vote 23 Yea, 0 Nay, and 2 Absent. The absent members were Representatives Bearinger and Thede. The bill will move to the House Floor as an Appropriations Committee Bill.
