### Consideration of Bills

Chairman Kaufmann surrendered the Chair to Representative Thompson.

Chairman Thompson recognized Representative Kaufmann for [HSB 508](#).

Representative Kaufmann introduced and opened discussion on [HSB 508](#) which is an act appropriating certain tax receipts concerning internet fantasy sports contests and sports wagering to the emergency medical services fund

Representative Kaufmann moved the bill [HSB 508](#)

The clerk took verbal vote

[HSB 508](#) moves to the floor as a committee bill with a vote of 19 yea 2 nay. Those voting Nay were Rep. Nielsen and Rep. Derry.

Chairman Thompson surrendered the Chair back to Representative Kaufmann

Chairman Kaufmann recognized Representative Deyoe for [HSB 520](#)

Representative Deyoe introduced and opened discussion on [HSB 520](#) which is an act prohibiting persons from simultaneously holding more than one elective office and including applicability provisions

Representative Deyoe moved the bill [HSB 520](#)  
The vote was a short form, unanimous, aye vote

Vote 25 yeas, amended as committee bill

Chairman Kaufmann recognized Representative Sorensen on [HSB 554](#)

Sorensen introduced and opened discussion on [HSB 554](#) which is an act relating to regulation of foods sold by minors

Representative Sorensen moved the bill [HSB 554](#)  
The clerk recorded a vote of 21 yeas
