The amendment passed on short form vote 13 yea 1 nay, with Senator Hogg voting nay. The bill as amended was discussed and was passed 9 yea 5 nay on roll call vote.

Senator Whiting was recognized for [SSB 3135](#). Senator Whiting was recognized for amendment [SSB 3135](#).3115. The amendment passed on short form vote 12 yea 2 nay, with Senator Hogg and Senator Taylor voting nay. The bill as amended was discussed and was passed 9 yea 5 nay on roll call vote.

Senator Dawson was recognized for [SF 2129](#). The bill passed 13 yea 1 nay on roll call vote.

Senator Garrett was recognized for [SF 571](#). Discussion followed. The bill passed 9 yea 5 nay on roll call vote.

Senator Dawson was recognized for [SF 2277](#). The bill passed on short form vote 14 yea 0 nay.

Senator Zaun turned the meeting over to Vice Chairman Garrett. Senator Zaun was recognized for [SSB 3136](#). Discussion followed. The bill passed on short form vote 12 yea 2 nay, with Senator Dawson and Senator Garrett voting no.
