The meeting came to order at 9:45 AM.

Roll call was taken silently by the committee secretary. Senators Shipley and Zumbach excused. Chairman Senator Rozenboom states the minutes from the last meeting were distributed electronically. Chairman Senator Rozenboom asked the committee members if there are any needed changes to the minutes. Seeing none, the minutes from February 18, 2020 are approved as distributed.

Chairman Senator Rozenboom asked for unanimous consent for the consideration of bills <u>SSB</u> <u>3062</u> and <u>SSB 3129</u>. Seeing no objection, so ordered.

Republicans and Democrats briefly caucused.

The meeting reconvened at 10:11 AM.

Chairman Senator Rozenboom recognized Senator Behn for <u>SSB 3062</u>.

Senator Behn introduced <u>SSB 3062</u> and provided the subcommittee report, drawing attention to the unanimous recommendation of passage by all three subcommittee members: Senators Behn, Segebart, and Hogg. Senator Behn gave opening comments on the bill and states there is an amendment.

Chairman Senator Rozenboom recognized Senator Behn for opening comments on Amendment 3175. Senator Behn gave opening comments and moved the amendment.

Senate Amendment 3062.3175 passes unanimously on short form voice vote.

Chairman Senator Rozenboom opened the floor to discussion regarding <u>SSB 3062</u> as amended. Seeing none, Chairman Rozenboom recognized Senator Behn for closing remarks on <u>SSB 3062</u>, as amended. Senator Behn provided final remarks and moved the bill.

<u>SSB 3062</u>, as amended, passes unanimously on a short form voice vote. Senate Study Bill 3062, as amended, moves to the Regular Calendar as a Committee Bill, waiving the requirement of Rule 40.

Chairman Senator Rozenboom concluded the meeting, drawing attention to what will take priority throughout the remainder of session. Primarily, House Files and educational presentations.
