- Senator Breitbach called the meeting to order at 11:00 a.m.
- Attendance was taken silently by the committee secretary.
- The minutes of February 20, 2020, were unanimously approved.
- Senator Breitbach recognized Senator Kraayenbrink for [SSB 3076](#). He noted the bill has an amendment, 3326. Democrats caucused in Room 24, and Republicans in Room 223 at 11:06 a.m. The meeting resumed at 11:28 a.m.
- The Chair recognized Senator Kraayenbrink for Amendment 3326 to [SSB 3076](#). Following his comments on the Amendment, the Chair asked for further discussion. Seeing none, a short form vote was requested and Amendment 3326 passed unanimously. Back on [SSB 3076](#), as amended, Senator Breitbach recognized Senator Kraayenbrink for opening comments on the bill, as amended. At the conclusion of Senator Kraayenbrink's opening remarks, the Chair asked for further discussion. Senators Mathis and Lofgren offered remarks. Seeing no further discussion, Senator Kraayenbrink was recognized for closing comments on [SSB 3076](#), as amended. A short form vote was requested and [SSB 3076](#), as amended, passed unanimously.
- The Chair then recognized Senator Shipley for [SF 2176](#). He noted that the sub-committee recommended passage, with an amendment. The Chair recognized him for comments on Amendment 3354 to [SF 2176](#). Senator Shipley offered opening comments on Amendment 3354 and the Chair asked for any discussion. Seeing none, the Chair asked how the Committee wanted to vote. A short form vote was requested and Amendment 3354 to [SF 2176](#) passed unanimously. Back on [SF 2176](#), as amended, Senator Shipley offered closing remarks. There were no comments. A short form vote was requested and [SF 2176](#), as amended, passed unanimously.
- The Chair recognized Senator Rozenboom for [SF 601](#). He offered opening remarks on the bill, and the Chair asked for discussion. In turn, Senators Bolkcom, Shipley and Dotzler were recognized for commentary. Seeing no further discussion, Senator Rozenboom gave closing remarks on [SF 601](#). A short form vote was requested and [SF 601](#) passed unanimously.
