SF 2301 (Chair-Deyoe, Mitchell Nielsen)

Chairman Carlson handed the Chair position over to VChair Rep. Jacobsen.

Rep. Jacobsen recognized Rep. Carlson for opening comments on <u>SF 2338</u>. Rep. Carlson indicated there was an Amendment .3912 and was recognized for opening comments on the amendment. There was discussion. Rep. Carlson then moved the amendment in short form. Amendment .3912 passed.

Rep. Jacobsen still acting as Chair, recognized Rep. B. Meyer for new Amendment .3984. Rep. Jacobson opened the floor for discussion on amendment .3984. After discussion, he moved the amendment and Rep. Meyer asked for a division and a record vote on the amendment. The amendment failed by a vote of 13 nays to 10 ayes.

Rep. Jacobsen recognized Rep. Carlson for closing comments on <u>SF 2338</u>, as amended. With no further discussion, Rep. Carlson moved <u>SF 2338</u>, as amended with a roll call vote. The vote was 13 ayes to 10 nays. <u>SF 2338</u>, as amended passes onto the House floor as a Senate file.

Chair Carlson recognized Rep. Mitchell for opening comments on <u>SF 2301</u>. There was discussion.

Rep. Mitchell was recognized for closing comments.

With no further discussion, Chair Carlson moved <u>SF 2301</u> as a Senate File onto the House floor with a roll call vote of 23 ayes and 0 nays.
