Chairman Mohr called the Appropriations meeting to order at 9:00 am in the House Chambers. He made some committee announcements and indicated they would be going to caucus immediately.

Chairman Mohr announced at 10:30 that the Appropriations Committee would recess until the end of the Judiciary committee.

The Appropriations committee reconvened at 11:50 am.

The committee was then recessed due to an Emergency Capitol alarm.

The committee reconvened again at 12:15 pm.

Chairman Mohr opened the meeting with attendance read by the clerk. All members were present.

Previous minutes were approved.

Chairman Mohr recognized Rep. Bossman for introduction of [SF 2188](#). Rep. Bossman opened the floor for discussion and questions which followed. He moved the bill.

Chairman Mohr moved the bill. Roll call was taken and [SF 2188](#) passed on a vote of 25 yeas to 0 nays with 0 absent. The bill moves to the floor as a Senate bill.

Chairman Mohr then recognized Rep. Brink for introduction of [SF 2349](#) with amendments.

Rep. Brink discussed the bill and Amendment .3993. After no more discussion, she moved the amendment.

Rep. Mascher called for a record roll call for the amendment.

Clerk called the roll call. The amendment passed with a vote of 25 yeas to 0 nays. With no other discussion on [SF 2349](#), as amended, Rep. Brink made motion to move the bill.

Chairman Mohr moved the bill. Clerk called the vote and [SF 2349](#), as amended. Vote was 14 yeas and 11 nays. The bill passes onto the House floor as a Senate file as amended.

Chairman Mohr recognized Rep. Dolecheck for [SF 2360](#) along with Amendment .3646. There was discussion. Rep. Dolecheck moved the amendment and Rep. Mascher called for a roll call vote. The vote was 25-0 with 25 yeas. The Amendment .3646 passes.

Rep. Mascher was recognized for Amendment.4041. After discussion, Rep. Mascher asked for a roll call vote on the Amendment. Chairman Mohr moved it to vote. The amendment passed with a 25-0 vote.

Rep. Mascher was recognized for Amendment. 3724. After brief discussion, Rep. Mascher asked for a roll call vote on the Amendment. Chairman Mohr moved it to vote. The amendment passed with a 25-0 yeas vote.

Rep. Mascher again was recognized for Amendment. 4011. There was discussion. Rep. Mascher

asked for a roll call vote. Chairman Mohr moved it to vote. The amendment passed with a 25-0 yeas vote.

Chairman Mohr recognized final comments by Rep. Dolecheck on [SF 2360](#), as amended. There were no other comments on the floor and Rep. Dolecheck moved out [SF 2360](#) as amended.

Chairman Mohr called the vote. The bill as amended will move to the House floor as a senate bill on a vote of 25-0 yeas.

Chairman Mohr recognizes Rep. Deyoe for [HF 2384](#) along with amendment. 4014. The floor opened for discussion and comments on Amendment. 4014. Rep. Mascher asked for a roll call vote on the amendment. It passed by a vote of 25-0.

Rep. Deyoe then moved the [HF 2384](#), as amended to the floor as a committee bill. Rep. Mohr asked for a vote. Final vote on [HF 2384](#) as amended was 25-0 ayes.

With no other business, Rep. Hall made the motion to adjourn at 1:10 pm.
