Approps committee meeting reconvened at 8:05 am in the House Chamber.

Attendance was taken. 23 present, 2 absent and a quorum is present.

Chairman Mohr approved the previous minutes and made announcements.

Chairman Mohr asked for dissolving of full committee into subcommittee as a whole which majority approved.

Chairman Mohr recognized Rep. Bossman for introduction and comments on [HSB 711](#). There was discussion.

Chairman Mohr asked if the public had questions or comments. There was discussion. Rep. Bossman moved [HSB 711](#) short form.

The subcommittee as a whole was dissolved by majority vote and full committee resumed. Rep. Bossman moved [HSB 711](#) to vote. The bill passed by a vote of 24 yea and 1 absent.

There was a pause for brief discussion.

Chairman Mohr moved the Chair position to Rep. Brink. Rep. Brink asked to bring the committee to a subcommittee as a whole. Majority approved by voice vote. Rep. Mohr introduces [HSB 710](#) and opened the floor for comments and discussion.

Rep. Brink acting as chair moved [hsb 710](#) in short form and it passes.

Rep. Brink dissolves the subcommittee as a whole back to full committee.

Rep. Mohr introduces amendment .4232 and opens for discussion and questions.

Rep. Mohr moves amendment .4232 and asks for a record roll call vote. The amendment failed by vote of 13 nay, 11 yea (Bearinger, Bennett, Hall, Forbes, McKean, Mascher, Oldson, Running-Marquardt, Thede, Williams and Winckler) and 1 absent.

Rep. Mohr introduces amendment .4207 and it passes on short form.

Back to [HSB 710](#) which passed short form in subcommittee as whole. Rep. Mohr asked to dissolve the subcommittee as a whole and back to full committee.

Rep. Mohr introduces [HSB 710](#) and asked for comments and discussion. [HSB 710](#) passes onto the floor by vote of 13 nay, 11 yea (Bearinger, Bennett, Hall, Forbes, McKean, Mascher, Oldson, Running-Marquardt, Thede, Williams and Winckler) and 1 absent.

Rep. Bossman introduces [HSB 712](#) and opens the floor to subcommittee as a whole. Opens the floor for discussion and questions. There were none.

Rep. Bossman moves the bill short form and it passes. Chair Mohr dissolves the subcommittee as a whole and back to full committee.

Rep. Bossman moves the bill, [HSB 712](#) and it passes as 14 yea and 10 no (Bearinger, Bennett, Hall, Forbes, Oldson, Running-Marquardt, Thede, Williams, Winckler) and 1 absent. It moves to the floor as a committee bill.

With no further business before the committee, Chairman Mohr made the motion to arise and Rep. Brink seconded. Adjourned at 9:50 am.
