Rep. Jones introduced [HF 97](#) which has an amendment 113. First was discussion of amendment 113. Rep. Jones moves the amended. It passed in short form.

Back to [HF 97](#) as amended. There was discussion. Rep. Jones moves the bill as amended.

There is a record roll call vote with 21 ayes and 2 nays (Konfrst, Wolfe). The bill as amended will move to the floor as a committee bill.
