On Febuary 1, 2021 at 2 p.m. the State Government Committee meeting was held in the Law Library.

At 1:58, Chairperson Kaufmann called the meeting to order and both parties immediately went to caucus.

The State Government Committee reconvened at 2:31.

The Roll was taken; all members were present.

The minutes from the previous meeting were approved.

Chairperson Kaufmann assigned no bills and announced there will be an electronic notice sent tomorrow and asked that the representatives continue with their subcommittee meetings.

Chairperson Kaufmann announced that <u>HF 143</u> will be postponed and there will be discussion of <u>HF 148</u>, <u>HSB 54</u>, <u>HSB 132</u>, and <u>HSB 57</u>.

Chairperson Kaufmann called for opening comments on <u>HSB 54</u> and introduced an amendment. There were no comments on the Amendment which Rep. Kaufmann moved with a voice vote. The amendment passed with an unanimous call of ayes. Chairperson Kaufmann then opened discussion on <u>HSB 54</u>, as amended. With no further discussion, he moved <u>HSB 54</u> as amended to the floor and called for a vote. The vote was 22 ayes and 0 nay. <u>HSB 54</u> as amended moves to the floor as a committee bill.

Opening comments were given on HSB 57 with discussion to follow.

After no further discussion, closing comments were given and the bill moved to the floor as a committee bill after a roll call vote of 17 ayes and 5 nayes (Bloomingdale, Meyer, Mitchell, Sexton, Siegrist).

HSB 132 was opened for comments and discussion. There is an amendment. After
