Senator Edler introduced <u>SSB 1062</u>, provided the subcommittee report, and gave opening comments on the bill. Senator Edler stated there is an Amendment 1062.358.

Vice Chair Costello recognized Senator Edler for opening comments on Amendment 1062.358. Senator Edler gave opening comments on the amendment.

Vice Chair Senator Costello opened the floor to discussion.

Seeing no discussion, Vice Chair Senator Costello recognized Senator Edler for closing comments on Amendment 1062.358.

Senate Amendment 1062.358 passed unanimously on a short form voice vote.

Vice Chair Senator Costello recognized Senator Edler for <u>SSB 1062</u> as amended.

SSB 1062 as amended passed 12-1 on a record vote with Senator Bolkcom voting no.

<u>SSB 1062</u> as amended moves to the Calendar as a Committee Bill under Rule 40.

Vice Chair Senator Costello recognized Senator Edler for SF 106.

Senator Edler introduced <u>SF 106</u>, provided the subcommittee report, and gave opening comments on the bill. Senator Edler stated there is an amendment.

Vice Chair Costello recognized Senator Edler for opening comments on Amendment 106.363. Senator Edler gave opening comments on the amendment.

Vice Chair Senator Costello opened the floor to discussion.

Vice Chair Senator Costello recognized Senator Trone Garriott who spoke in favor of amendment.

for closing comments on Amendment 106.363.

Senate Amendment 106.363 passed unanimously on a short form voice vote.

Vice Chair Senator Costello recognized Senator Edler for <u>SF 106</u> as amended.

Seeing none, Vice Chair Senator Costello recognized Senator Edler for closing comments on <u>SF 106</u> as amended. Senator Edler provided closing comments and moved the bill.

<u>SF 106</u> as amended passed unanimously on a short form voice vote and moves to the Calendar as a Committee Bill under Rule 40.

Vice Chair Senator Costello recognized Senator Edler for <u>SSB 1095</u>.

Senator Edler introduced <u>SSB 1095</u>, provided the subcommittee report, and gave opening comments on the bill.

Vice Chair Senator Costello opened the floor to discussion.

Vice Chair Senator Costello recognized Senator Mathis who emphasized good discussion that was had during sub committee meeting and is in favor of this bill. Senate File 81 passed 8-5 on a record vote with Senators Mathis, Bolkcom, Jochum, Ragan, and Trone Garriott voting no. <u>SF 81</u> moves to the Calendar as an individual bill.

Chairman Senator Edler recognized Senator Carlin for <u>SF 125</u>.

Senator Carlin introduced <u>SF 125</u>, provided the subcommittee report, and gave opening comments on the bill.

Chairman Senator Edler opened the floor to discussion.

Chairman Senator Edler recognized Senator Bolkcom who spoke in opposition to the bill

Seeing no further discussion, Chairman Senator Edler recognized Senator Carlin for closing comments on <u>SF 125</u>. Senator Carlin provided closing comments and moved the bill

Senate File 125 passed 8-5 on a record vote with Senators Mathis, Bolkcom, Jochum, Ragan, and Trone Garriott voting no. <u>SF 125</u> moves to the Calendar as an individual bill

Chairman Senator Edler asked Ranking Member Mathis for clarification on the record vote for <u>SSB 1062</u>. Ranking Member Mathis provided clarification.

Ranking Member Mathis motioned to adjourn.
