Chairman Senator Edler recognized Senator Lofgren for HF 260.

Senator Lofgren introduced <u>HF 260</u>, provided the subcommittee report, and gave opening comments on the bill.

Chairman Senator Edler opened the floor to discussion.

Chairman Senator Edler recognized Senator Mathis who expressed concern for the bill.

Seeing no further discussion, Chairman Senator Edler recognized Senator Lofgren for closing comments on <u>HF 260</u>. Senator Lofgren provided closing comments and moved the bill.

House File 260 passes 8-5 with Senators Mathis, Bolkcom, Jochum, Ragan, and Trone Garriott voting no. <u>HF 260</u> moves to Calendar.

Chairman Senator Edler recognized Senator Costello for <u>SSB 1185</u>.

Senator Costello introduced S<u>SSB 1185</u>, provided the subcommittee report, and gave opening comments on the bill. Costello states there is an amendment.

Chairman Senator Edler recognized Senator Costello for opening comments on Amendment 625. Senator Costello provided opening comments on the amendment. Chairman Senator Edler opened the floor to discussion.

Seeing none, Chairman Senator Edler recognized Senator Costello for closing comments on amendment 625. Senator Costello provided closing remarks and moved the amendment.

Amendment 1185.625 passes unanimously on a short form voice vote.

Vice Chair Senator Costello recognized Senator Edler for <u>SSB 1193</u>.

Senator Edler introduced <u>SSB 1193</u>, provided the subcommittee report, and gave opening comments on the bill.

Seeing none, Vice Chair Senator Costello recognized Senator Edler for closing comments on <u>SSB 1193</u>. Senator Edler provided closing comments and moved the bill.

SSB 1193 passes unanimously on a short form voice vote and moves to the Calendar as a Committee Bill under Rule 40.

Vice Chair Senator Costello recognized Chairman Senator Edler for <u>SSB 1158</u>. Senator Edler introduced S<u>SSB 1158</u>, provided the subcommittee report, and gave opening comments on the bill. Senator Edler states there is an amendment.
