Sen. Smith, R. called the meeting to order at 3:17pm.

The roll was taken silently by the secretary.

All members were present.

The minutes from the previous meeting were approved.

Both parties caucused.

Sen. Brown was recognized for [SSB 1046](#). Sen. Brown presented the subcommittee report. Amendment 1046.825 was called up. The amendment passed unanimously via short form. The bill passed via short form (10-5) with Senators Bisignano, Boulton, Celsi, Giddens, and Jochum voting no.

Sen. Reichman was recognized for [SSB 1151](#). Sen. Reichman presented the subcommittee report. Amendment 1151.764 was called up. The amendment passed via short form (14-1) with Sen. Goodwin voting no. The bill passed via short form (10-5) with Senators Bisignano, Boulton, Celsi, Goodwin, and Jochum voting no.

Sen. Brown was recognized for [SF 218](#). Sen. Brown presented the subcommittee report. There were no amendments. The bill passed unanimously via short form.

Sen. Dawson was recognized for [SSB 1165](#). Sen. Dawson presented the subcommittee report. Amendment 1165.839 was called up. The amendment passed unanimously via short form. The bill passed via short form (11-4) with Senators Boulton, Celsi, Giddens, and Jochum voting no.

Sen. Johnson was recognized for [SSB 1171](#). Sen. Johnson presented the subcommittee report. Amendment 1171.711 was called up. The amendment passed via record with 9 aye, 5 no, 1 present. The bill passed via short form with Senators Bisignano, Boulton, Celsi, Giddens, and Jochum voting no. Senator Bisignano requested [SSB 1171](#) as amended be referred to the Senate Appropriations committee.

Sen. Cournoyer was recognized for [SSB 1178](#). Sen. Cournoyer presented the subcommittee report. Sen. Boulton was recognized for amendment 1178.855. Sen. Boulton asked for a division of the amendment. Division A is page 1 lines 1-7 and Division B was the remainder of the amendment. Sen. Boulton was recognized for Amendment 1178.855A. Amendment 1178.855A failed a record vote with 5-10. Sen. Boulton withdrew amendment 1178.855B. Amendment 1178.815 with Sen.

Cournoyer was called up. Amendment 1178.815 passed unanimously via short form. The bill passed via short form with Senators Boulton, Celsi, and Jochum voting no.

Sen. Reichman was recognized for [SSB 1201](#). Sen. Reichman presented the subcommittee report. The bill passed unanimously via short form.

Sen. Cournoyer was recognized for [SSB 1203](#). Sen. Cournoyer presented the subcommittee report. The bill passed via short form (11-4) with Senators Bisignano, Boulton, Celsi, and Jochum voting no.
