Chairwoman Senator Sinclair called the meeting to order at 11:03 am.

Roll was taken silently with 15 members present.

The minutes from the 2/24/21 meeting were approved.

Republican and Democrat Senators caucused at 11:04am. The meeting reconvened at 11:31am.

Chairwoman Senator Sinclair recognized Senator Carlin for [SF 304](#). Senator Carlin introduced [SF 304](#), delivered the subcommittee report, and gave opening remarks on the bill. Senator Carlin offered amendment [SF 304](#).985 to the bill. Seeing no discussion, Senator Carlin moved the passage of the amendment. The amendment passed on a short form vote. Chairwoman Senator Sinclair recognized Ranking Member Senator Quirmbach for remarks support of the bill, as amended.

Chairwoman Senator Sinclair recognized Senator Carlin for final remarks and move passage of [SF 304](#), as amended. A short form vote was taken, none opposed, and the bill passed and moved to the calendar under Rule 40.

Chairwoman Senator Sinclair relinquished the chair to Vice Chair Senator J Taylor. Chairman Senator J Taylor recognized Senator Sinclair for [SF 430](#). Senator Sinclair introduced [SF 430](#), delivered the subcommittee report, and gave opening remarks on the bill. Senator Sinclair offered amendment [SF 430](#).838 and gave remarks.

Senator J Taylor recognized Senator Giddens, Ranking Member Senator Quirmbach and Senator Trone Garriott for comments on the amendment. Chairman Senator J Taylor recognized Senator Sinclair for final comments and to move passage of the amendment. The amendment was passed on a roll call vote of 10-5, with Senators Quirmbach, Celsi, Giddens, J Smith and Trone Garriott voting nay. Chairman Senator J Taylor recognized Ranking Member Senator Quirmbach, Senator Trone Garriott and Senator J Taylor, each for remarks on [SF 430](#), as amended. Chairman Senator J Taylor recognized Senator Sinclair. Senator Sinclair moved passage of [SF 430](#), as amended. A short form vote was taken and the bill passed and was moved to the calendar under Rule 40. Chairwoman Senator Sinclair resumed the chair.

Chairwoman Senator Sinclair recognized Senator Cournoyer for [SF 452](#). Senator Cournoyer introduced [SF 452](#), delivered the subcommittee report, and gave opening remarks on the bill. Senator Cournoyer offered amendment [SF452](#).988 and gave remarks. Chairwoman Senator Sinclair recognized Ranking Member Senator Quirmbach for comments in support of the amendment. Chairwoman Senator Sinclair recognized Senator Cournoyer who moved the amendment. The amendment passed on a short form vote. Seeing no discussion on the bill, Chairwoman Senator Sinclair recognized Senator Cournoyer. Senator Cournoyer moved the bill as

amended. A short form vote was taken, none opposed, and [SF 452](#), as amended passed and was moved to the calendar under Rule 40.

Chairwoman Senator Sinclair recognized Senator Johnson for [SSB 1219](#). Senator Johnson introduced [SSB 1219](#), delivered the subcommittee report, and gave opening remarks on the bill. Senator Johnson offered amendment [SSB 1219.1032](#). Seeing no discussion, Senator Johnson moved the passage of the amendment. The amendment passed on a short form vote. Chairwoman Senator Sinclair recognized Senator J Smith and Senator Trone Garriott for comments on the bill. Chairwoman Senator Sinclair recognized Senator Johnson. Senator Johnson moved passage of [SSB 1219](#), as amended. A roll call vote was taken and the bill passed 10-5, with Senators Quirnbach, Celsi, Giddens, J Smith, and Trone Garriott voting Nay. [SSB1219](#), as amended, was moved to the calendar as a committee bill under Rule 40.

Chairwoman Senator Sinclair recognized Senator Cournoyer for [SSB 1231](#). Senator Cournoyer introduced [SSB 1231](#), delivered the subcommittee report, and gave opening remarks on the bill. Chairwoman Senator Sinclair recognized Senator Trone Garriott for remarks in support of [SSB 1231](#). Chairwoman Senator Sinclair recognized Senator Cournoyer. Senator Cournoyer moved passage of [SSB 1231](#). A short form vote, none opposed, was taken and the bill passed and was moved to the calendar as a committee bill.

Senator Goodwin moved to adjourn. Adjourned at 11:55am.
