MINUTES LEGISLATIVE FISCAL COMMITTEE of the LEGISLATIVE COUNCIL October 21, 2003

The Legislative Fiscal Committee of the Legislative Council met October 21, 2003. The meeting was called to order at 10:05 a.m. with the following members present:

The following agenda items were discussed:

- Minutes: Approved minutes of the September 23, 2003, meeting.
- Revenue Update: Received a revenue update including a report on current General Fund balances for FY 2003 and FY 2004.
 - Holly Lyons, Director, Fiscal Services Division, Legislative Services Agency (LSA), provided a
 revenue update and information from the October 10 meeting of the Revenue Estimating Conference
 (REC). The revised FY 2004 estimate for net General Fund receipts was decreased by \$142.2 million.
 The REC also developed the first estimate for FY 2005 receipts. That estimate projects net revenues
 will be \$10.4 million below the level projected for FY 2004.
 - Dave Reynolds, LSA, reviewed the Governor's 2.5% Across-the-Board Reduction. Randy Bauer,
 Budget Director, Department of Management, was present to answer questions. The six Charter
 Agencies are exempt from the across-the-board reductions as required in SF 453 (Reinvention of
 Government Act). Co-Chairperson Dix indicated the Legislative Branch will reduce its budget by the
 2.5% reduction and indicated the Judicial Branch will make its own decision regarding the reduction.
- **Medicaid:** Jennifer Vermeer, LSA, reviewed various Medical Assistance (Medicaid) related expenditures. This included:
 - The FY 2004 Medicaid expenditures.
 - An update regarding the Healthy and Well Kids in Iowa (hawk-i) Program.
- Capitol Security: Jennifer Acton, LSA, presented information from an Issue Review regarding security issues within the Capitol Complex. Senator Bolkcom and Representative Shoultz questioned the need for the current level of security within the

Capitol Complex. Lt. Dave Garrison, Department of Public Safety, stated there have been several encounters with visitors to the Capitol Complex since September 11, 2001. Mr. Garrison also stated the total number of incidents at the Capitol Building has decreased since security has been present at the Building entrances.

- National Highway Traffic Safety Administration Incentives (0.08%): Jennifer Acton, LSA, presented information regarding the federal funds available for the enactment of the 0.08% blood alcohol content limit.
- Discussion of Agenda Topics for December 17: These include:
 - Revenue Update REC Possible invitation of an economist to review the economy and a member of the REC for a review of the estimates.
 - Balance Sheet Updates, including:
 - General Fund
 - Rebuild Iowa Infrastructure Fund (RIIF)
 - Restricted Capital Fund

 - Endowment for Iowa Health Account
 - Healthy Iowans Tobacco Trust
 - Update on FY 2005 Built-in Increases and Decreases
 - FY 2005 Department Requests
 - Lease Purchases and Transfers
 - School District Insurance Pool Study
 - Update on the Grow Iowa Values Fund
 - State Indebtedness Report
 - Update on the actuarial soundness of the Iowa Public Employment Retirement System (IPERS) and the Judicial Retirement Fund
 - Various statutory reports due in December or January
 - Reinvent Government Progress Report
 - Racing Association of Central Iowa (RACI) Case Update
 - Impact of RACI Case on RIIF
 - Public Strategies Group (PSG) Update Timeline of PSG activities/Quarterly Report Update
- On-Line Benefit Enrollment for State Employees: Ed Holland, Human Resources Enterprise, Department of Administrative Services, reviewed the On-Line Program for employee benefit enrollment and reasons for changing to this Program.

• Reinvent Government:

Sue Lerdal, LSA, reviewed the progress report for SF 453 (Reinvention of Government Act). She also
presented an update on Charter Agencies.

- Babak Armanjani, Public Strategies Group (PSG), presented an update on the focus items within Reinvention of Government. He reviewed the "Smart Spending Phase 2 Project Deliverables and Outcomes" for each of the following including their goals and timelines:
 - Child Welfare Reform
 - Local Government John Easter, Iowa State Association of Counties; and Susan Judkins, Iowa League of Cities; reviewed the concerns that their respective organizations have regarding the State-Local Governments proposals.
 - Charter Agencies six agencies have agreed to become Charter Agencies. They are the
 Department of Human Services; Iowa Veterans Home; Department of Revenue; Department of
 Natural Resources; Department of Commerce, Alcoholic Beverages Division; and the Department
 of Corrections.
 - The discussion included:
 - Development and measure of FY 2004 budget baselines for comparison of increased revenues.
 - The fee paid to the PSG and timing for payment. The contract indicates that the PSG will
 receive 5.0% when the additional revenues are certified and a second 5.0% when outcome
 results are confirmed with a cap of \$6.3 million.
 - Concern regarding the progress and challenges in communication within the process.
- Valuation Impact Upon School Aid: Dwayne Ferguson, LSA, provided information regarding a \$20.0 million increase to the FY 2005 estimate for the State cost for K-12 School Aid funding due to the recent decline in property valuations.
 - Dick Stradley, Department of Revenue, explained the reason for the decline of 2.0% in comparison
 with the previous estimate of an increase of 2.0% in property valuations. He explained the purpose of
 the Property Tax Implementation Committee, and reviewed the subcommittees' members and
 responsibilities. The Committee will consider equalization, assessment limitations, and assessment
 limitations with levy limits plus rollbacks; and will review non-profit governments and responsibility
 for costs incurred by such use of property tax revenues; definitions of categories and classes; and
 possible property tax system challenges.
 - Mr. Stradley presented a summary of 2003 Tentative Equalization Adjustments, Assessor Revaluation
 Actions and Equalization actions between agricultural, residential, and commercial land. Cerro Gordo,
 Woodbury, Warren, and Dickinson counties are participating in the pilot project.
- Request: Senator Gronstal requested information on the Legislative Council lawsuit against the Governor: how much has been paid to date to the attorneys, whether or not the expenses are billed and paid monthly, and the status of the lawsuit. Ms. Lyons indicated the legal expenditures as of October 21 regarding the item veto lawsuit are \$48,498. Senator Gronstal requested the Legislative Fiscal Committee advise the Legislative Council to limit legal costs at \$200,000. Co-chairperson Dix agreed that such a limit should be possible.
- Senator Bolkcom stated that the K-12 school systems be able to present challenges of the 2.5% across-the-board appropriation reduction at the December meeting. Members agreed to also include the Board of Regents in the presentation.
- Adjournment: Motion by Senator Gronstal to adjourn the meeting at 1:55 p.m. The motion was seconded and passed unanimously.
