State Government committee meeting was called to order in the Law Library at 2 pm by Chair Kaufmann.

Both parties immediately went to caucus.

The meeting reconvened at 4:45 pm.

Chairman Kaufmann recognized Rep. Siegrist for opening comments on [HSB 247](#). There was discussion. After discussion, Rep. Siegrist made the motion to move the bill to vote. Vote was called and [HSB 247](#) passed to the floor as a committee bill on a vote of 23 yays and 0 nays with 0 absent.

Chairman Kaufmann next recognized Rep. Lundgren for [HSB 59](#). There is an amendment .716. After discussion the amendment passed short form. Back to [HSB 59](#) as amended. Rep. Lundgren moved [HSB 59](#), as amended, for vote. With a vote of 23 yays to 0 nays with 0 absent, [HSB 59](#) as amended moves to the floor as a committee bill.

Chairman Kaufmann next recognized Rep. Bloomingdale for [HSB 60](#). There is an amendment. The amendment .831 was introduced. After discussion, the amendment.831 passed short form. Back to [HSB 60](#), as amended. Rep. Bloomingdale moves [HSB 60](#) as amended to vote. With a vote of 23 yays to 0 nays with 0 absent, [HSB 60](#), as amended moves to the floor as committee bill.

Chairman Kaufmann next recognized Rep. Mitchell for [HSB 200](#). There was discussion. Rep. Mitchell moved [HSB 200](#) to vote. Vote call was taken and [HSB 200](#) passed on a vote of 17 yay (Kaufmann, Boden, Bloomingdale, Bossman, Cohoon, Gjerde, Jacobsen, Jones, A. Meyer, Mitchell, Lundgren, T. Moore, Nordman, Sexton, Siegrist, Wilburn, Wolfe) 6 nay (Bacon, Mascher, Bohannon, Donahue, Hunter, Konfrst) with 0 absent.

Chairman Kaufmann next recognized Rep. Ann Meyer for [HSB 215](#). There is an amendment.791. After discussion, the amendment passed on short form. Back to [HSB 215](#), as amended. Rep. Ann Meyer moves [HSB 215](#) as amended to vote. With a vote of 23 ayes to 0 nays with 0 absent, [HSB 215](#) as amended moves to the floor as a committee bill.

Chairman Kaufmann next recognized Rep. Jones for [HF 637](#). There is an amendment.975. The amendment passed on short form. Back to [HF 637](#), as amended. Rep. Jones moved [HF 637](#) as amended to a vote. [HF 637](#) as amended passes with vote of 23 yay with 0 nay and 0 absent. [HF 637](#) as amended moves to the floor as a committee bill.

Chairman Kaufmann next recognized Rep. Sexton for [HSB 214](#). There is an amendment .953. The amendment was voted on short form and passed. Back to [HSB](#)

[214](#) as amended. After discussion, Rep. Sexton moves [HSB 214](#) as amended to vote. Vote was called and [HSB 214](#) as amended passes on vote of 21 yays (Kaufmann, Boden, Mascher, Bacon, Bloomingdale, Bohannan, Bossman, Cohoon, Donahue, Gjerde, Jacobsen, Jones, Konfrst, A. Meyer, Mitchell, T. Moore, Nordman, Sexton, Siegrist, Wilburn, Wolfe) with 2 nays (Hunter, Lundgren) and 0 absent. Chairman Kaufmann next recognized Rep. T. Moore for [HF 46](#). There is an amendment.<sup>834</sup> After discussion, the amendment passed short form. Back to [HF 46](#) as amended. Rep. T. Moore moves [HF 46](#) as amended to vote. With a vote of 23 yays to 0 nay with 0 absent, [HF 46](#) as amended moves to the floor as a committee bill. Chairman Kaufmann handed the Chair role to Vice Chair Boden. Chairwoman Boden recognized Rep. Kaufmann for [SF 183](#). There was discussion and questions. Rep. Kaufmann moved [SF 183](#) to a vote. Vote was 13 yays (Kaufmann, Boden, Bacon, Bloomingdale, Bossman, Jacobsen, Jones, Lundgren, A. Meyer, Mitchell, Nordman, Sexton, Siegrist) to 10 nays (Mascher, Bohannan, Cohoon, Donahue, Gjerde, Hunter, Konfrst, T. Moore, Wilburn, Wolfe) with 0 absent. [SF 183](#) passes to the floor as a committee bill. Chairwoman Boden handed the Chair role back to Rep. Kaufmann. Chairman Kaufmann declared with no other business before the committee, the meeting is ready to adjourn. Rep. Siegrist made the motion to adjourn with Rep. Jones seconding the motion. The meeting adjourned at 5:30 pm.
