Both parties immediately went to caucus and at 10:15 am they reconvened and chairperson Kaufmann called the meeting to order.

Roll was taken. A quorum was present.

Minutes from the previous meeting were approved.

Chairperson Kaufmann dissolved the committee into a sub committee to discuss HSB 268.

He gave opening comments, and allowed members of the public to give their comments.

The bill moved as a short form after a unanimous call of ayes.

The sub committee returned to full committee and Chairperson Kaufmann turned the chair to Representative Boden.

Chairperson Boden recognized Representative Kaufmann for opening comments on <u>HSB 268</u>.

There was discussion. Rep. Kaufmann moved the bill to vote. Vote was called and HSB 268 moves to the floor as a committee bill with a vote of 23 ayes (Kaufmann, Boden, Bacon, Bloomingdale, Bohannan, Bossman, Cohoon, Donahue, Gjerde, Hunter, Jacobsen, Jones, Konfrst, Lundgren, Mascher, Meyer, Mitchell, Moore, Nordman, Sexton, Siegrist, Wilburn, Wolfe).

Chairperson Boden recognized Representative Kaufmann for opening comments on <u>HSB 245</u>. There is an amendment. Rep. Kaufmann introduced the amendment and there was discussion.

The amendment passed by short form. Back to <u>HSB 245</u> as amended. Rep.

Kaufmann introduced **HSB 245** as amended. There was discussion.

Kaufmann gave closing comments on HSB 245 as amended and read a testimony

from a constituent.

HSB 245, as amended moved to the floor as a committee bill with a roll call vote of 14 ayes (Kaufmann, Boden, Bacon, Bloomingdale, Bossman, Jacobsen, Jones, Lundgren, A. Meyer, Mitchell, Moore, Nordman, Sexton, Siegrist) and 9 nayes (Mascher, Bohannan, Cohoon, Donahue, Gjerde, Hunter, Konfrst, Wilburn, Wolfe) Chairperson Boden recognized Representative Kaufmann for opening comments on HF 481.

The floor was opened for comments. There was discussion.

Representative Kaufmann gave closing comments and moved <u>HF 481</u> to the floor as a committee bill with a vote of 14 ayes (Kaufmann, Boden, Bacon, Bloomingdale, Bossman, Jacobsen, Jones, Lundgren, A. Meyer, Mitchell, Moore, Nordman, Sexton, Siegrist) and 9 nayes (Mascher, Bohannan, Cohoon, Donahue, Gjerde, Hunter, Konfrst, Wilburn, Wolfe).

Chairperson Boden returned the chair to Representative Kaufmann, who recognized Representative Bloomingdale for opening comments on HSB 269.

There was discussion. Representative Bloomingdale gave closing comments and moved <u>HSB 269</u> to the floor as a committee bill with a roll call vote of 22 ayes and 1 naye (Jacobsen).

Chairperson Kaufmann recognized Representative Lungdren for opening comments on HF 252. There was discussion from the committee.

Representative Lungdren made closing comments on HF 252 and moved it to the floor as a committee bill after a roll call vote fo 14 ayes (Kaufmann, Boden, Bacon, Bloomingdale, Bossman, Jacobsen, Jones, Lundgren, A. Meyer, Mitchell, Moore, Nordman, Sexton, Siegrist) and 9 nayes (Mascher, Bohannan, Cohoon, Donahue, Gjerde, Hunter, Konfrst, Wilburn, Wolfe)

Chairperson recognized Representative Jones for opening comments on <u>HF 640</u>. There is an amendment. Rep. Jones opened the floor for discussion on the amendment and moved it. The amendment passed short form.

<u>HF 640</u>, as amended, was discussed and with no further discussion, Rep. Jones moved <u>HF 640</u> as amended to vote. <u>HF 640</u> as amended moves to the floor as a committee bill with vote of 23 ayes to 0 nayes with 0 absent.

Representative Jacobsen gave opening comments on <u>HF 346</u> and there is an amendment.

There was discussion on the amendment from the committee. Rep. Jacobsen moved the amendment to vote short form and it passed. Back to <u>HF 346</u> as amended. <u>HF 346</u> as amended was discussed and Rep. Jacobsen moved to vote on <u>HF 346</u> as amended which moves to the floor as a committee bill with a vote of 23 ayes and 0 naves with 0 absent.

Representative Jones gave opening comments for <u>HSB 264</u> and there is an amendment. Discussion on amendment which Rep. Jones moved to vote. The amendment passes short form. Back to <u>HSB 264</u> as amended. There was discussion. Rep. Jones moved <u>HSB 264</u> as amended to the floor for vote. <u>HSB 264</u> as amended moves to the floor as committee bill with a vote of 23 ayes, 0 nayes and 0 absent. Chairperson Kaufmann recognized Representative Bossman for opening comments on <u>HSB 210</u>.

There was discussion from the committee. Rep. Bossman moved <u>HSB 210</u> to the floor as committee bill by a vote of 21 ayes (Kaufmann, Boden, Mascher, Bacon, Bloomingdale, Bohannan, Bossman, Cohoon, Gjerde, Hunter, Jacobsen, Jones, Lundgren, A. Meyer, Mitchell, Moore, Nordman, Sexton, Siegrist, Wilburn, Wolfe) and 2 nayes (Donahue, Konfrst).

Chairperson Kaufmann recognized Representative Bacon for opening comments on HF 599. There is an amendment to the bill. Rep. Bacon introduced the amendment and moved it to vote. The amendment passed short form. Back to HF 599 as amended. After discussion, Rep. Bacon moved HF 599 as amended to the floor as a committee bill with a vote of 23 ayes to 0 nayes with 0 absent.

Seeing that there was no further business to come before the committee, Chairperson Kaufmann adjourned the meeting at 11:26.
