Senator Kraayenbrink entertained a motion to convene a Subcommittee of the Whole on [SSB 1258](#). Senator Guth moved and a unanimous vote approved.

Senator Kraayenbrink recognized Senator Guth for opening comments on [SSB 1258](#).

Senator Guth presented an overview of the Admin & Regulation Budget. Senator Kraayenbrink entertained questions from the public and lobby. Hearing none, Senator Kraayenbrink entertained comments from the floor. Senators Celsi and Peterson commented. Seeing no further comments, Senator Kraayenbrink recognized Senator Guth for closing comments. Senator Guth moved [SSB 1258](#). A record vote was requested. [SSB 1258](#) passed with 13 yeas; 8 nays (Bolkcom, Celsi, Dotzler, Mathis, Petersen, Ragan, J. Smith, T. Taylor) The bill passed out of subcommittee.

A comment was made by J. Smith. Following closing comments on Amendment 1828, Senator Cournoyer moved the amendment. Short form vote was requested. Amendment 1828 passed unanimously.

Senator Kraayenbrink entertained a motion to dissolve the subcommittee. Senator Cournoyer moved to arise from the Subcommittee of the Whole and return to Full Committee for consideration of [HF 532](#) as amended.

Senator Kraayenbrink recognized Senator Cournoyer for opening comments on [HF 532](#) as amended. Seeing no discussion, Senator Kraayenbrink recognized Senator

Cournoyer for closing comments. Senator Cournoyer simply moved the bill. Short form vote was requested. [HF 532](#) passed unanimously. With no further business to come before the committee, Senator Petersen moved to adjourn.
