Senator Kraayenbrink called the meeting to order.

Attendance was taken silently by the committee secretary. The minutes of the last meeting were approved.

Senator Kraayenbrink listed the Governor's Appointments under consideration by the committee. The following appointments were considered and moved by the subcommittee chairs.

All three appointments passed unanimously with a short form vote. The appointees were placed on the En Bloc confirmation calendar with the committee's recommendation.

Senator Kraayenbrink entertained a motion to convene a Subcommittee of the Whole on [SSB 1267](#). Senator Costello moved and a unanimous vote approved.

Senator Kraayenbrink recognized Senator Costello for opening comments on [SSB 1267](#). Senator Costello gave an overview of the Health and Human Services Budget.

Senator Kraayenbrink entertained comments from the public or members of the lobby. Tom Chapman, Iowa Catholic Conference, and Leslie Carpenter, Iowa Mental Health Advocacy, were recognized for comments. Senator Kraayenbrink entertained questions from the floor. Senator Ragan was recognized for comments. Senator Kraayenbrink recognized Senator Costello for closing comments. Senator Costello moved [SSB 1267](#). A record vote was requested. [SSB 1267](#) passed out of subcommittee with 12 yeas; 7 nays (Bolkcom, Celsi, Dotzler, Petersen, Ragan, J. Smith, T. Taylor).

Senator Kraayenbrink entertained a motion to dissolve the subcommittee. Senator Costello moved to arise from Subcommittee of the Whole and return to Full Committee for consideration of [SSB 1267](#).

Senator Kraayenbrink recognized Senator Costello for opening comments on [SSB 1267](#). With no additional opening comments, Senator Costello introduced Amendment 2141. With no discussion, Senator Costello simply moved the amendment. Short form vote was requested. Amendment 2141 passed unanimously. Back on [SSB 1267](#) as amended. With no further discussion, Senator Kraayenbrink recognized Senator Costello for closing comments. Senator Costello moved [SSB 1267](#) as amended. A record vote was requested. [SSB 1267](#) as amended passed with 12 yeas; 7 nays (Bolkcom, Celsi, Dotzler, Petersen, Ragan, J. Smith, T. Taylor).
