Chairman Dawson called the meeting to order at 4:20 p.m. Republican and Democrat senators went to caucus. Senator Dawson called the meeting back to order at 5:02 p.m.

The secretary took the roll call silently. Any senators not present (Senator Schultz and Senator Whiting) were excused until they arrived. A quorum was present. Senator Dawson moved the minutes of the meeting held on April 20th, 2021 be approved. The minutes were approved on voice vote.

[HF 837](#) was pulled from the agenda and [SF 442](#) was added.

Senator Smith was recognized for a subcommittee of the whole over [SF 442](#). It passed unanimously on a short form vote. Senator Smith was recognized for [SF 442](#) in the standing committee. The bill passed unanimously on a short form vote with 15 yeas and 0 nays.

Senator Sinclair was recognized by Chairman Dawson for [HF 847](#). Senator Sinclair was recognized for an amendment to [HF 847](#). The amendment passed unanimously on a short form vote with 15 yeas and 0 nays. The bill as amended was discussed. The bill as amended passed on short form vote, 15 yeas 0 nays.

Senator Sweeney was recognized by Chairman Dawson for [HF 728](#). The bill passed on short form vote, 10 yeas 5 nays. Senators Bolkcom, Jochum, Petersen, Quirmbach, and T. Taylor voted nay.

Senator Goodwin was recognized by Chairman Dawson for [HF 838](#). Senator Goodwin was recognized for an amendment to the bill. The amendment passed unanimously on a short form vote with 15 yeas and 0 nays. The bill as amended was discussed. The bill as amended passed on a short form vote, 12 yeas 3 nays. Senators Jochum, Petersen, and Quirmbach voted nay.

Senator Dickey was recognized by Chairman Dawson for [HF 828](#). The bill passed unanimously on short form vote.

Senator Brown was recognized by Chairman Dawson for [HF 846](#). The bill passed unanimously on short form vote.

Senator Smith was recognized by Chairman Dawson for [HF 865](#). The bill passed unanimously on short form vote.

Senator Dawson was recognized by Vice Chairman Goodwin for [SSB 1268](#). The bill passed unanimously on short form vote, 15 yeas 0 nays.

Senator Dawson was recognized by Vice Chairman Goodwin for [SSB 1269](#). Senator T. Taylor was recognized for an amendment to the bill. The amendment passed on a short form vote with 6 yeas and 9 nays. Those voting nay were Senators Dawson, Goodwin, Brown, Carlin, Dickey, Green, Sinclair, Smith, and Sweeney. The amendment failed. The bill passed on short form vote, 15 yeas 0 nays.

Senator Brown moved to arise. The meeting adjourned at 5:50pm.
