The Amendment failed with the votes of 9 ayes (Jacoby, Brown-Powers, Gjerde, Isenhardt, James, Kurth, McConkey, Wessel-Kroeschell, Wolfe) - 14 nays (Hein, Nordman, Bergan, Bloomingdale, Boden, Graber, Hite, Kaufmann, Lohse, Lundgren, Maxwell, Osmundson, Sieck, Wheeler) - 2 absent (Mitchell, Staed).

The representatives discussed on the bill. The Chair recognized Representative Hite for closing remarks on [HSB 273](#). Representative Hite moved the bill. [HSB 273](#) passed as a Ways and means bill with votes 23 ayes (Hein, Nordman, Jacoby, Bergan, Bloomingdale, Boden, Brown-Powers, Gjerde, Graber, Hite, Isenhardt, James, Kaufmann, Kurth, Lundgren, Maxwell, McConkey, Mitchell, Osmundson, Sieck, Wessel-Kroeschell, Wheeler, Wolfe) - 0 nays- 2 absent (Mitchell, Staed)

The Chair recognized Representative Graber for opening remarks on [SF 363](#). There was an amendment. Chair recognized Representative Wolfe for Amendment 2158. The Representatives discussed. The Chair recognized Representative Wolfe for

closing remarks and moved Amendment 2158. The Amendment failed with the votes of 9 ayes (Jacoby, Brown-Powers, Gjerde, Isenhardt, James, Kurth, McConkey, Wessel-Kroeschell, Wolfe) - 15 nays (Hein, Nordman, Bergan, Bloomingdale, Boden, Graber, Hite, Kaufmann, Lohse, Lundgren, Maxwell, Mitchell Osmundson, Sieck, Wheeler) - 1 absent (Staed). The Chair recognized Representative Graber for closing remarks on [SF 363](#). Representative Graber moved the bill. [SF 363](#) passed as a Ways and Means bill with votes 13 ayes (Hein, Nordman, Bergan, Bloomingdale, Boden, Graber, Hite, Kaufmann, Lohse, Lundgren, Maxwell, Osmundson, Sieck) - 11 nays (Jacoby, Brown-Powers, Gjerde, Isenhardt, James, Kurth, McConkey, Mitchell, Wessel-Kroeschell, Wheeler, Wolfe) - 1 absent (Staed). Let the record of these minutes show that Rep. Gjerde voted Nay incorrectly on [SF 363](#), but the error was not noted until after adjournment. The Nay vote in error must stand as is for the record vote but reflects in the minutes.
