Chairman Holt called the Judiciary Committee meeting to order at 2:00 p.m. after both parties had returned from caucus.

Roll call was taken with all members present.

Chairman Holt announced how the Committee would run during today's meeting and then moved into a subcommittee of the whole to consider [HF 889](#).

For one hour, the public in attendance wishing to speak for or against the legislation were heard for up to three minutes each.

At the end of the hour, members of the subcommittee as a whole were invited to comment on [HF 889](#).

With no further discussion, Rep. Holt moved [HF 889](#) to full Committee on a voice vote and with that passage, the subcommittee of the whole dissolved and Committee came back to order at 3:11 p.m.

Chairman Holt turned the Chair over to Representative Gustafson.

Chair Gustafson recognized Representative Holt for opening comments of [HF 889](#).

Rep. Holt indicated there was an amendment.

Chair Gustafson recognized Representative Jacobsen for opening comments on Amd .2211. There was discussion. Chair Gustafson recognized Rep. Jacobsen for closing comments and Rep. Jacobsen moved the amendment. Chair Gustafson called for a voice vote and the amendment failed.

With no further discussion on [HF 889](#), Rep. Holt was recognized for closing remarks and Rep. Holt moved the bill.

Chair Gustafson moved [HF 889](#) as a Leadership Bill on a roll call vote of 16 ayes (Representatives Holt, Gustafson, Wolfe, Bohannon, Hansen, Hite, Jacobsen, Kaufmann, Klein, B. Meyer, Mitchell, Osmundson, Salmon, Westrich, Wheeler, Wills) and 5 nays (Representatives Lohse, Oldson, Olson, Wessel-Kroeschell, Wilburn).

Chair Gustafson returned the Chair back to Chairman Holt.
