The State Government committee meeting was called to order by Chairman Kaufmann at 10:30 am on 10/28/21 in Room 103.

Chairman Kaufmann announced that both parties would go to caucus immediately.

The committee meeting reconvened at 12:05 pm.

Attendance was taken and all 23 members were present.

The last meetings minutes were approved.

Chairman Kaufmann moved to dissolve from full committee to subcommittee and handed the Chair position to Representative Boden.

Chairwoman Boden recognized Rep Kaufmann for [HSB 280](#). He opened the floor for committee member questions. He then opened the floor for others in attendance to each have 1 minute to speak if they wish. After discussion, Representative Kaufmann moved [HSB 280](#) short form to pass out of subcommittee by majority.

Representative Kaufmann introduced Amendment .2644 which is a clarifying amendment to [HSB 280](#) and asked for discussion. After discussion, Representative Kaufmann moved Amendment.2644 in short form which passed by majority out of subcommittee.

Chairwoman Boden then dissolved the subcommittee and moved back to committee as a whole and handed the Chair back to Representative Kaufmann.

Representative Kaufmann moved [HSB 280](#), as amended to a vote.

The clerk called the vote. [HSB 280](#), as amended passed onto the floor as a committee bill by a vote of 22 yays to 1 nay (Representative Jacobsen), 0 absent.

Chair Kaufmann recognized Representative Stone to introduce [HSB 281](#). Chair Kaufmann then dissolved of whole committee into subcommittee and opened the floor for public members to go to the podium for 1 minute each of comments.

After the public comments, Chairman Kaufmann then opened the floor for discussion of committee members.

After discussion, Chairman Kaufmann dissolved the subcommittee as a whole back to full committee.

Representative Stone moved [HSB 281](#) to a vote.

The clerk called the vote. [HSB 281](#) passed to the House Floor as a committee bill with a vote of 16 yays (Representatives Kaufmann, Boden, Bacon, Bloomingdale, Bohannon, Bossman, Jacobsen, Jones, Lundgren, Mitchell, T. Moore, Nordman, Sexton, Siegrist, Stone and Wolfe) and 7 nays (Representative Mascher, Cohoon, Donahue, Gjerde, Hunter, Konfrst, and Wilburn) with 0 absent.

With no other business to come before the committee, Representative Stone moved to adjourn at 1:37 pm.
